#### Statutory information

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as Liquidator of the Companies on 19 February 2013

The Companies' registered numbers are detailed above. Their former registered office and principal trading address was 33 Cavendish Square, London, W1G 0PW. The Companies' registered office was changed to 55 Baker Street, London, W1U 7EU following my appointment.

Catalyst Quartet Wigmore Limited was formerly known as Ever 2096 Limited, changing to the present name on 11 June 2003. The remaining Companies have no former names, and none of the Companies have any trading styles.

#### Receipts & Payments

There have been no receipts or payments in the liquidation period.

The Companies' sole assets are intercompany debtor balances owed by group companies as detailed in the attached schedule. These amounts were distributed in specie to the Companies' shareholders prior to this meeting of members.

#### Liquidator's Remuneration

My remuneration was approved on a time costs basis on the date of my appointment. The costs of the liquidations will be paid by an appropriate associated company.


#### Liquidation Closure

Formal tax clearance from HM Revenue & Customs has been received in respect of Corporation Tax and VAT for the pre-liquidation periods, together with confirmation that no further returns are required and there are no objections to the liquidations being closed.

The shareholders are invited to consider the following resolutions:

- 1 That the Liquidator's report and accounts to 10 March 2014 be and are hereby approved
- 2 That the Liquidator is authorised to dispose of the Company's books and records one year after the dissolution of the Company
- 3 The Liquidator is released


