ACTIVITIES DURING THE YEAR

NLCA continues to provide valuable community services to the Chinese population in North London, predominantly in Brent, Barnet and Harrow. The Association is run by currently 5 Directors / Trustees and volunteers. We hold a weekly meeting and surgery for our members and also open to the general public, on a Thursday at the Hyde Church in Colindale, which also has a Chinese church congregation and therefore is familiar to the Chinese community.

The services provided at the weekly sessions include (but not exclusively) translation of papers and correspondence members received; general advice and signposting on issues of housing, schools, benefits, visas, employment, tax and legal matters and also emotional support for the weak and vulnerable.

The weekly sessions are well received and also provide a meeting point to encourage social cohesion and promote Community spirit. Apart from the weekly sessions, we also organised for the members and general public in any one year, at least 4 main gathering and activities celebrating 1) Christmas and New Year; 2) Chinese New Year, 3) Dragon Boat Festival and 4) Mid Autumn (also called Moon Cake) Festival. The timing of these 4 events are approximately 3 months apart and provides a good spread of activities throughout the year.

In the coming year, we aim to organise further specific seminars and talks for the members on health (elderly and women),
