#### NOTES TO THE FINANCIAL STATEMENTS

#### 1 ACCOUNTING POLICIES

The principal accounting policies are summarised below. They have all been applied consistently throughout the period.

## **Basis of accounting**

The financial statements have been prepared on a going concern basis under the historical cost convention and in accordance with the Companies Act 1985 and applicable United Kingdom accounting standards, on the basis of continued support from the group.

#### Cash flow

A cash flow statement has not been prepared as the company has taken advantage of the exemption under FRS1 (Revised 1996) available to wholly owned subsidiaries of a company incorporated in the EU whose consolidated financial statements include a consolidated cash flow statement.

#### Oil futures contracts

Oil futures contracts are valued at the lower of cost and market value. Any movements are reflected in the profit and loss account.

#### **Taxation**

Current tax, including UK corporation tax and foreign tax, is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted or substantially enacted by the balance sheet date.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more tax in the future or a right to pay less tax in the future have occurred at the balance sheet date. Timing differences are differences between the company's taxable profits and its results as stated in the financial statements that arise from the inclusion of gains and losses in tax assessments in periods different from those in which they are recognised in the financial statements.

A net deferred tax asset is regarded as recoverable and therefore recognised only when, on the basis of all available evidence, it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

## **NOTES TO THE FINANCIAL STATEMENTS (continued)**

Deferred tax is not recognised when fixed assets are revalued unless by the balance sheet date there is a binding agreement to sell the revalued assets and the gain or loss expected to arise on sale has been recognised in the financial statements. Neither is deferred tax recognised when fixed assets are sold and it is more likely than not that the taxable gain will be rolled over, being charged to tax only if and when the replacement assets are sold.

Deferred tax is recognised in respect of the retained earnings of overseas subsidiaries and associates only to the extent that, at the balance sheet date, dividends have been accrued as receivable or a binding agreement to distribute past earnings in future has been entered into by the subsidiary or associate.

Deferred tax is measured at the average tax rates that are expected to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

During the year the Babcock International Group has continued its policy of surrendering tax losses and advance corporation tax to group undertakings for no consideration except where there is a minority interest in the subsidiary, and except for the Peterhouse companies acquired part-way through the accounting period.

## 2 STAFF COSTS AND DIRECTORS REMUNERATION

There were no staff employed during the period and none of the directors received remuneration in respect of their services to the company during the period under review.

The directors are remunerated by other group companies.

#### 3 TAXATION

There is no corporate tax credit for the period, as the loss on the derivative contract has been surrendered for nil consideration. (There was no corporate tax credit for the previous period as the loss on the derivative contract was not tax deductible during that period. There was no deferred tax asset for the previous period as the loss, when deductible, was expected to be surrendered as group relief for nil consideration.)

## 7 RELATED PARTY TRANSACTIONS

#### 8 DERIVATIVE CONTRACT

The oil contract was settled on 27 September 2003. This resulted in a loss of £20,009,600, of which £5,200 has been recognised in the period. The remainder of the loss of £20,004,400 was recorded in the accounts for the period to 25 September 2003.

## 9 ULTIMATE CONTROLLING PARTY

The immediate parent undertaking is Babcock Investments Limited. The company's ultimate parent company is Babcock International Group PLC, a company registered in England and Wales. The only group in which the results of the company are consolidated is that headed by Babcock International Group PLC.
