1. CONTINGENCIES

JLA Disposal Limited, JLA Recycling Limited and Celtic Minor Limited, fellow subsidiary companies, and Tir Canol Holdings Limited, the parent company, are party to a cross guarantee in respect of the group's bank borrowings.
