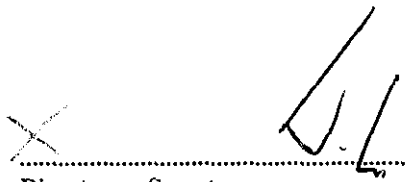

REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF FENDER FARM
MANAGEMENT COMPANY LIMITED

We have audited the financial statements of Fender Farm Management Company Limited for the year ended 30th November 2005 on pages five to eight. 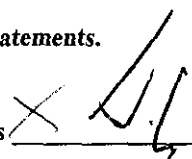
