Year ended 31 December 2023

1. General information

The company is a private company limited by guarantee, registered in England. The address of the registered office is 377 Hoylake Road, Moreton, Wirral, CH46 0RW.

2. Statement of compliance

These financial statements have been prepared in compliance with the provisions of FRS 102, Section 1A, 'The Financial Reporting Standard applicable in the UK and Republic of Ireland'.

3. Accounting policies

Basis of preparation

The financial statements have been prepared on the historical cost basis, as modified by the revaluation of certain financial assets and liabilities and investment properties measured at fair value through profit or loss.

The financial statements are prepared in sterling, which is the functional currency of the entity.

4. Limited by guarantee

The company is limited by guarantee and has no share capital. In the event of a winding up, each of the members would be required to contribute up to a maximum of £1.

Where an overdrawn balance exceeds the de minimis limit, interest is charged at H M Revenue and Customs official rate.
