

DEED OF RELEASE (FULL) of Debentures

PARTIES

- (1) LLOYDS TSB BANK PLC whose registered office is at 25 Gresham Street, London, EC2V 7HN (the "Bank")
- (2) THE COMPANIES listed in Schedule 2

THIS DEED WITNESSES THAT:

1 RELEASE

In consideration of the receipt of all outstanding sums owed by the Companies to the Bank, the Bank:

- 1.1 hereby releases and reassigns to the Companies all the property, assets and undertakings of the Companies charged or assigned under the terms of the security documents set out in Schedule 1 to this Deed including all claims, demands, covenants, mortgages, assignments, charges, guarantees, indemnities, obligations and liabilities of whatsoever nature comprised within the security documents thereunder; and
- 1.2 the Bank agrees that it will, at the expense of the Companies, do all things and execute any further documents as the Companies may reasonably require for the purpose of giving effect to this Deed.

2 CONTINUATION OF LIABILITY

This Deed shall not discharge the Companies from any liability to the Bank remaining to be paid or from any other security.

3 INDEMNITY

The Companies shall indemnify the Bank for all any reasonable costs, losses, damages, expenses, claims and liabilities incurred or suffered by the Bank as a result of any attempt to clawback any amounts already paid to the Bank.

4 GOVERNING LAW AND JURISDICTION

This Deed shall be governed by and construed in all respects in accordance with English law. The courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed (including a dispute regarding the existence, validity or termination of this Deed or any non-contractural obligation arising out of or in connection with this Deed).

IN WITNESS whereof this Deed has been executed as a Deed by the Bank, but shall only be treated as having been delivered and taking effect as a Deed upon being dated.
