ORDER

AND UPON Peter Shaw KC, Counsel for the Applicants, appearing

AND UPON Stephen Hunt having filed with the court (a) a statement of qualification to act as an insolvency practitioner in relation to the Company and (b) a consent to act as liquidator of the Company

IT IS ORDERED THAT:



1. The administration of the Company be terminated and the appointment as administrators of the Joint Administrators shall cease to have effect forthwith;
2. The Company be wound up by the court;
3. Stephen Hunt of Griffins, Tavistock House South, Tavistock Square, London, WC1H 9LG, be appointed liquidator of the Company;
4. The Joint Administrators be discharged on the 28th day following filing of their final report;
5. Pursuant to r.12.30 Insolvency (England and Wales) Rules 2016 and CPR r.30.2 the insolvency proceedings (namely the administration of) Messiah Corporation Limited transferred to the Business and Property, Insolvency and Companies List sitting at the Royal Courts of Justice;
6. The costs of this application be an expense of the administration.
