

UPON the application dated the 9<sup>th</sup> day of November 2017

AND UPON this application having been considered on paper and the documents filed having been read

IT IS ORDERED THAT:

1. Each of the County Court cases listed in Schedules A, B, C & H (attached to this order) be transferred to the High Court of Justice, Chancery Division, Companies Court for the purpose only of making this order.
