**WRITTEN RESOLUTION

Pursuant to section 641(a) and Chapter 2 Part 13 of the Companies Act 2006, the directors of the Company proposed that the following resolutions be passed as a special resolution (the "Resolution"):

**SPECIAL RESOLUTION**

1. THAT, the issued share capital of the Company be reduced from 4,182,000 ordinary shares of £1.00 each to 1 ordinary shares of £1.00 each by cancelling and extinguishing 4,181,999 of the issued ordinary shares of £1.00 each in the Company, each of which is fully paid, and the amount by which the share capital is so reduced be credited to the Company's profit and loss account.
2. THAT, the share premium account of the Company of £18,526,582, be cancelled and reduced to £0.00 and the amount of the share premium account so cancelled be credited to the Company's profit and loss account.
