The company was incorporated on 6 March 2003. The company was dormant during the year ended 31 December 2015 and did not trade, accordingly no profit and loss account has been produced.




For the year ended 31 December 2015 the company was entitled to exemption under section 480 of the Companies Act 2006 relating to dormant companies.

1. Accounting policies

Basis of preparation

The report and financial statements are prepared under the historical cost convention and in accordance with applicable United Kingdom accounting standards, including Financial Reporting Standard 102 - 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102').

This is the first year in which the financial statements have been prepared under FRS 102. The Company has transitioned from previously extant UK GAAP to new UK GAAP (FRS 102) for all periods presented. There were no material adjustments to the financial statements arising on the adoption of FRS 102 and hence no reconciliation of equity and profit and loss have been prepared.

No profit and loss account has been prepared, as the company did not trade throughout the financial year.

Statement of cash flows

Under the provisions of Financial Reporting Standard 102, the company is exempt from preparing a statement of cash flow because it qualifies as a small company as defined by sections 382 to 384 of the Companies Act 2006.
