THIS ACCESSION DEED is made on 6 September 2013 between

- (1) THE COMPANIES LISTED IN SCHEDULE 1 (*The Acceding Charging Companies*) (each an "Acceding Charging Company"),
- (2) FITNESS FIRST FINANCE LIMITED, a limited liability company incorporated in England and Wales with registered number 05452198 and having its registered office at 58 Fleet Lane, Poole, Dorset, BH15 3BT (the "Initial Charging Company"), and
- (3) WILMINGTON TRUST (LONDON) LIMITED (as Security Agent for the Secured Parties (as defined below)) (the "Security Agent")

Background

- (a) This Accession Deed is supplemental to a fixed and floating security document dated 6 August 2013 and made between the Initial Charging Company and the Security Agent (the "Debenture")
- (b) The Acceding Charging Companies are entering into this Accession Deed in connection with the Finance Documents

IT IS AGREED as follows

1 DEFINITIONS AND INTERPRETATION

1.1 Definitions

Terms defined in, or construed for the purposes of, the Debenture have the same meanings when used in this Accession Deed, including in the recital to this Accession Deed, unless otherwise defined herein

1.2 Construction

Clause 1.2 (*Construction*) of the Debenture applies with any necessary changes to this Accession Deed as if it were set out in full in this Accession Deed

2 ACCESSION OF THE ACCEDING CHARGING COMPANIES

2.1 Accession

Each Acceding Charging Company

- (a) unconditionally and irrevocably undertakes to and agrees with the Security Agent to observe and be bound by the Debenture, and
- (b) creates and grants at the date of this Accession Deed the charges, mortgages, assignments and other security which are stated to be created or granted by the Debenture,

as if it had been an original party to the Debenture as an Initial Charging Company

2.2 Undertaking to pay

Without prejudice to the generality of Clause 2.1 (*Accession*), each Acceding Charging Company (jointly and severally with the other Charging Companies and each other Acceding Charging Company) covenants in the terms set out in clause 2 (*Undertaking to pay*) of the Debenture

2.3 Charge and assignment

Without prejudice to the generality of Clause 2.1 (*Accession*), each Acceding Charging Company with full title guarantee charges and assigns (and agrees to charge and assign, as may be required) to the Security Agent for the payment and discharge of the Secured Obligations, all its right, title and interest in and to the property, assets and undertaking owned by it or in which it has an interest, on the terms set out in clauses 3 (*Fixed Charges*), 4 (*Assignment*) and 5 (*Floating Charge*) of the Debenture, including (without limiting the generality of the foregoing)

- (a) by way of first legal mortgage, all Real Property in England and Wales specified against its name in Part I of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any),
- (b) by way of first fixed equitable charge, all other Real Property now belonging to it and all Real Property acquired by it in the future except the properties specified against its name in Part II and Part III of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any),
- (c) subject to Clause 2.5 (*Real Property*), by way of first fixed equitable charge, each Real Property specified against its name in Part II of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any) (but only with effect from the date that the relevant landlord's consent has been obtained for charging of that Real Property in accordance with clause 7.3(a) (*Existing Real Property*) of the Debenture),
- (d) by way of first fixed charge, all the Investments (including, without limitation, those specified against its name in Part IV of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any)) but excluding (i) in respect of Fitness First Limited the shares it owns in Fitness First Germany Holdings GmbH, a company incorporated in Germany with registration number HRB 48794 (Frankfurt am Main, Germany) ("**FFGH**") and (ii) in respect of Fitness First Overseas Holdings Limited the shares it owns in SPORTathlon Asia Sdn Bhd, a company incorporated in Malaysia with registration number 634734-H ("**SPORTathlon**" and together with FFGH, the "**Excluded Subsidiaries**"),
- (e) subject to Clause 2.6 (*National Westminster Accounts*) below, by way of first fixed charge, each of its Bank Accounts and its other accounts with any bank or financial institution at any time (including, without limitation, those specified against its name in Part V of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto and all monies at any time standing to the credit of such accounts,
- (f) by way of first fixed charge, all Intellectual Property (including, without limitation, the Intellectual Property specified against its name in Part VI of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any)),
- (g) by way of first fixed charge, all its present and future plant and machinery (except that mortgaged or charged by paragraph (a) above but including the plant and machinery specified against its name in Part VII of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any)),

- (h) subject to Clause 2.4 (*Notices of Assignment*), by way of absolute assignment, the Relevant Contracts (including, without limitation, those specified against its name in Part VIII of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any)), all rights and remedies in connection with the Relevant Contracts and all proceeds and claims arising from them, and
- (i) by way of absolute assignment, the Insurances (including, without limitation, those specified against its name in Part IX of Schedule 2 (*Details of Charged Assets owned by the Acceding Charging Companies*) hereto (if any)), all claims under the Insurances and all proceeds of the Insurances

2.4 Notices of Assignment

So long as no Event of Default is continuing, the Acceding Charging Companies shall only be obliged to comply with paragraph (a)(ii) of clause 4.2 (*Notice of assignment and/or charge – immediate notice*) of the Debenture three months after the date of this Accession Deed at which time they shall within five Business Days of such date notify the other party to the Relevant Contract in accordance with that clause 4.2 (*Notice of assignment and/or charge – immediate notice*) of the Debenture. If within such three months period an Event of Default occurs which is continuing, the Acceding Charging Companies shall be immediately obliged to comply with paragraph (a)(ii) of clause 4.2 (*Notice of assignment and/or charge – immediate notice*) of the Debenture

2.5 Real Property

So long as no Event of Default is continuing, the Acceding Charging Companies shall only be obliged to comply with paragraph (a) of clause 7.3 (*Existing Real Property*) of the Debenture three months after the date of this Accession Deed at which time they shall promptly apply for the relevant landlords' consent in accordance with that clause 7.3 (*Existing Real Property*) of the Debenture. If within such three months period an Event of Default occurs which is continuing, the Acceding Charging Companies shall be immediately obliged to comply with paragraph (a) of clause 7.3 (*Existing Real Property*) of the Debenture

2.6 National Westminster Accounts

The accounts with account numbers [REDACTED] and [REDACTED] held in the name of Fitness First Limited with National Westminster Bank Plc shall not be charged by any provision of this Accession Deed or the Debenture, whether by way of fixed charge pursuant to paragraph (e) of Clause 2.3 (*Charge and assignment*) above or clause 3 (*Fixed Charges*) of the Debenture or floating charge pursuant to clause 5 (*Floating Charges*) of the Debenture or otherwise

2.7 Investments in Excluded Subsidiaries

Notwithstanding any other term of this Accession Deed, any Investments held in the Excluded Subsidiaries, shall not be charged or assigned under paragraph (d) of Clause 2.3 (*Charge and assignment*) of this Accession Deed, clause 3 (*Fixed Charges*) of the Debenture or clause 5 (*Floating Charge*) of the Debenture and shall be expressly excluded from the Security created under this Accession Deed

2.8 Consent

Pursuant to clause 22 (*Changes to Charging Companies*) of the Debenture, the Initial Charging Company

- (a) consents to the accession of each Acceding Charging Company to the Debenture on the terms of this Accession Deed, and
- (b) agrees that the Debenture shall, after the date of this Accession Deed, be read and construed as if each Acceding Charging Company had been named in the Debenture as a Charging Company

3 CONSTRUCTION OF DEBENTURE

This Accession Deed shall be read as one with the Debenture so that all references in the Debenture to "this Deed" and similar expressions shall include references to this Accession Deed

4 THIRD PARTY RIGHTS

A person who is not a party to this Accession Deed has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce or enjoy the benefit of any term of this Accession Deed

5 NOTICE DETAILS

6 COUNTERPARTS

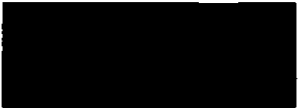

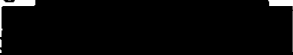

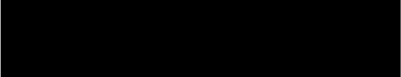
