- 1 Introduction and Statutory Information
- 1.1 I, Michael David Rollings, together with my partner Steven Edward Butt, of Rollings Butt LLP, 6 Snow Hill, London, EC1A 2AY, United Kingdom, was appointed as Joint Liquidators of Fleets Lane Holdings Limited (the Company) on 3 September 2018. This report provides an update on the progress in the liquidation for year ended 2 September 2020 (the Period).
- 1.2 Information about the way that we will use, and store personal data on insolvency appointments can be found at www.rollingsbutt.com/legal. If you are unable to download this, please contact us and a hard copy will be provided to you.
- 1.3 The registered office of the Company was changed to 52 Willis Way, London, SW1E 5DH and its registered number is 04699401.
- 2 Progress of the Liquidation
- 2.1 This section of the report provides creditors and members with an overview of the work undertaken in the liquidation since 3 September 2019, together with information on the overall outcome of the liquidation.
- 2.2 At Appendix A, I have provided an account of my Receipts and Payments for the Period, with a comparison to the Declaration of Solvency values, together with a cumulative account since my appointment.
- 2.3 As advised previously, the statutory compliance matters required on appointment were undertaken, including publishing the Notice of our Appointment as Liquidators and Notice to creditors to submit claims in the London Gazette.
- 2.4 In the reporting period, all outstanding tax returns up to 2 September 2018 have been submitted. The only outstanding matter preventing the liquidation from being concluded is obtaining tax clearance from HM Revenue & Customs.
- 3 Distributions to Members
- 3.1 The Company had no assets and therefore there have been no distributions made to the members.
- 4 Joint Liquidators' Remuneration
- 4.1 The members approved that the basis of the Liquidators' remuneration be fixed by reference to the time properly spent by them and their staff in attending to matters in the liquidation.
- 4.2 My time costs for the Period are £1,134. This represents 3.9 hours at an average rate of £290.77 per hour. Attached as Appendix B is a Time Analysis which provides details of the activity costs incurred by staff grade during this period in respect of the costs fixed by reference to time properly spent by me in managing the Liquidation.
- 4.3 Also attached as Appendix C is a cumulative Time Analysis for the period from the date of my appointment to 2 September 2020 which provides details of the total time costs incurred since the date of liquidation.
- 4.4 I can advise that since my last progress report, I have drawn £2,399 plus disbursements of £174.90 in relation to the pre-and post-appointment period. I can confirm that no further fees or expenses will be drawn.

### Appendix D

Additional Information in Relation to Joint Liquidators' Fees

- 1 Staff allocation and the use of subcontractors
