THURSDAY

in respect of a debt owed by Fumi Eugenio to Unicredit Credit Management Bank S.P.A. and assigned to the Claimant where it is alleged that the Properties have been transferred to the ownership of the Company in order to deprive the creditor of its ability to recover the debt due referred to in paragraphs 11 to 16 of the Witness Statement of Michele L. Savasta Fore dated the 3 July 2023 and paragraph 3 of his Second Witness Statement dated the 28 August 2023 immediately the Company is joined as a co-Defendant

(B) inform the Registrar of Companies immediately the proceedings and Writ of Execution are served on the Company referred to in paragraph 15 of the Witness Statement



(C) inform the Registrar of Companies immediately on the conclusion of the said litigation insofar as it is against the Company or of any appeal therefrom or on the conclusion of the claim against the Company if by any other means

AND UPON the solicitors for the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED that:

- (1) the name of the above named Health Software Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 04743476 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300.00

(6) the hearing fixed for the 7th December 2023 be vacated
