1. Overview of the liquidation



Introduction

Following my appointment as Liquidator of the Company on 7 May 2013 I set out herein my final account of the liquidation and confirm that the affairs of the Company are now fully wound up. This report provides an overview of the liquidation and details work done and expenses incurred during the period since my last progress report to date.

Following my appointment, I wrote to creditors on 8 May 2013 notifying them of my appointment and to set out a summary of the information I had regarding the Company's assets and liabilities and the likely anticipated outcome for creditors.

Details of work undertaken since my appointment have been set out in previous progress reports to creditors.

Work undertaken by the Liquidators during the Period

A schedule of work undertaken during the Period is attached at $\mbox{\bf Appendix}~\mbox{\bf C}.$

Receipts and payments account

Attached at **Appendix B** is a receipts and payments account detailing both transactions for the Period and cumulatively since my appointment as Liquidator, together with the costs and expenses in dealing with this liquidation which are further discussed in section 3 below.

As shown on the account all known assets have been realised.

There were insufficient funds available to make a distribution to creditors. The final outcome for creditors is set out in section 2 below.

Investigations

Part of my duties include carrying out proportionate investigations into what assets the Company has, including any potential claims that could be brought by the Company or by me in my capacity as Liquidator against any party which could result in a benefit to the estate. I have reviewed the Company's books and records and

NJM Roofing Limited (In Liquidation) The Liquidator's Final Account accounting information, requested further information from the directors, and invited creditors to provide information on any concerns they have concerning the way in which the Company's business has been conducted.

Further details of the conduct of my investigations are set out in the schedule of work attached.

My enquiries have now been finalised and I comment as follows:

Following a review of the schemes and investigation into the various potential claims the Liquidators may have had, along with the fact that legislation changed regarding recoveries from HMRC, combined with the potential solvency of the directors, a decision was taken to discontinue the investigation and recovery action on a commercial basis.

2. Final outcome for the creditors



The final outcome for creditors is set out below:

Outcome for secured creditors

There will be no distributions made in respect of the fixed and floating charges held by Nat West Bank Plc and HSBC respectively, as there was no debt due at the date of the liquidation.

Preferential Creditors

The following preferential creditors' claims have been received.

There will not be sufficient funds available to pay a distribution to preferential creditors.

Unsecured creditors

I have received claims totalling £441,855.74 from unsecured creditors.

There were insufficient realisations to pay a distribution to unsecured creditors.

Pursuant to the Insolvency Rules no dividend will be declared to preferential and unsecured creditors as the funds realised will be utilised in defraying the expenses of the liquidation.

The Prescribed Part

NJM Roofing Limited (In Liquidation) The Liquidator's Final Account In accordance with the Insolvency Act 1986 the prescribed part is an element of net realisations due to the floating charge holder which is made available for unsecured creditors (subject to the floating charge post-dating 15 September 2003).

As there was no debt due to the floating charge holder, the prescribed part did not apply in this instance.

Liquidators' remuneration

As advised in previous correspondence the creditors passed a resolution that the Liquidators' remuneration should be calculated on a time cost basis. In accordance with the approval obtained, fees of £28,664.12 excluding VAT have been drawn from the funds available.

A breakdown of my firm's time costs incurred during both the Period and to date is attached at ${\bf Appendix\ D.}$

Liquidators' disbursements

The Liquidators' disbursements are a recharge of actual costs incurred by the Liquidator in dealing with this matter. Mileage payments made for expenses relating to the use of private vehicles for business travel, which is directly attributable to the insolvency estate, are paid by FRP at the HMRC approved mileage rate prevailing at the time the mileage was incurred, as approved by the creditors. Details of disbursements incurred during the Period are set out in **Appendix D**.

Expenses of the liquidation

I attach at $\mbox{\bf Appendix E}$ a statement of expenses that have been incurred during the Period and cumulatively.

Creditors' Rights

Creditors have a right to request further information from the Liquidator and also have a right to challenge the Liquidators' remuneration and other expenses, which are first disclosed in this report, under the Insolvency Rules.
