1 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

Turnover

Turnover comprises of income received from participation fees, ticket sales and other sundry activities in relation to the November 2009 show, exclusive of value added tax

Deferred income and expenditure

All income received and expenditure incurred in the year in respect of November 2010 Lord Mayor's Show have been carried forward as income and expenditure and will be recognised in the year in which the show takes place

2 Share Capital

The Company is Limited by guarantee and has no share capital
