1. ACCOUNTING POLICIES

Basis of preparing the financial statements - going concern

At year end the company had a deficiency of net assets amounting to £9,317 (2013: £8,067). Included in this figure is an amount of £11,922 (2013: £8,162) due to the director who has agreed not to seek repayment until such time as funds allow and as a result, the accounts have been prepared on a going concern basis.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Fixtures & furniture	- 25% on cost
Computer equipment	- 25% on cost

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
