1. INTRODUCTION

I refer to the appointment of the Joint Liquidators of the Company on 16 January 2020.

This is my final account to the member as all matters have now been concluded and the Liquidation can now be finalised. This report covers the period 16 January 2021 to 12 January 2022 (Reporting Period) however, it also contains details of matters taken throughout the course of the liquidation and should be read in conjunction with my previous annual report, (copies of which can be obtained from this office on request, free of charge)

The Company's statutory information is detailed at Appendix I.

2. LIQUIDATORS' ACTIONS SINCE APPOINTMENT

The following actions have been undertaken since my appointment and up to the previous reporting period:

- Upon appointment I arranged for the formal notices to be issued to the relevant parties,
- Declared an in-specie distribution to the member of the Companies on 31 March 2020.
- Communicated with creditors regarding any potential claims and
- Liaised with HM Revenue & Customs ("HMRC") for pre-appointment and final taxation clearances

The following actions have been undertaken in the Reporting Period:

- Prepared and circulated my annual report to the member on 10 March 2021
- Continued to liaise with HMRC for final taxation clearances,
- Prepared my draft and this final account and
- Taken steps to finalise the liquidation

The matters undertaken during the course of the solvent liquidation process have been statutory in nature and whilst there is no direct benefit to the member, the work has been completed under a fixed fee agreement.

3. RECEIPTS AND PAYMENTS

Attached at Appendix II is the receipts and payments account for the period 16 January 2021 to 12 January 2022.

4. ASSETS

The Declaration of Solvency ("DOS") indicated there was an intercompany debtor totalling £1.

The full value of the debtor in respect to each of the Companies were in-specie distributed to its member on 31 March 2020, leaving no further assets to realise.

No other assets have been identified during the Liquidation.

5. LIABILITIES

There were no liabilities listed on the Declaration of Solvency for this Company.

I advertised for creditor claims in the London Gazette and as a result no claims were received that were relevant to the Companies.

6. DISTRIBUTIONS TO THE MEMBER

On 31 March 2020, I distributed £1 in-specie to the member of the Company by way of a first and final distribution of capital at a rate of £1 per ordinary share to the member Aspect Ventures Ltd.



There will be no further distributions to the member.

## 7. LIQUIDATORS' REMUNERATION AND EXPENSES

Written resolutions of the member dated 16 January 2020 resolved that the Joint Liquidators' remuneration should be fixed at £1,875 plus VAT for each of the Companies for assisting with the preparation of the Declaration of Solvencies, and the winding up of the Companies. This payment has been received.




