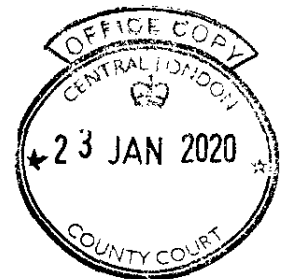

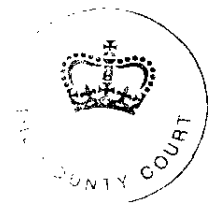

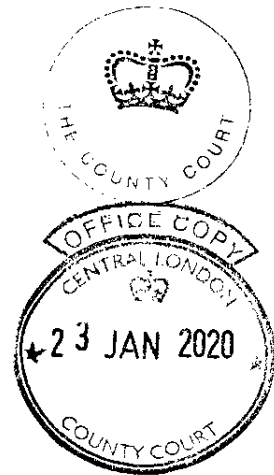
AND UPON READING the Witness Statement of Charlotte Jane Suzanne Winter dated 8 October 2019.
