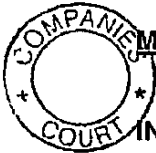

AND UPON the Secretary of state having been given notice by email sent on 6 November 2013
IT IS ORDERED THAT:-



1. That the person identified as "joint administrator" in Schedule 1 to this Application, Mr Michael Finch, of Moore Stephens LLP, be joined as Applicant pursuant to Rule 7.10C(5) of the Insolvency Rules 1986 (the "Rules").

2. That where the Respondent(s) are appointed as joint liquidator or joint administrator, as the case may be, the joint liquidator or joint administrator as the case may be, have the power to act jointly and severally so that all functions may be exercised by any or all of them

3. 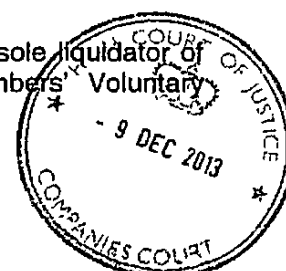

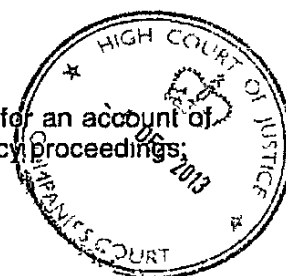

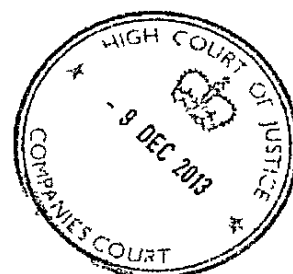

36. The Applicant is not required to produce any progress reports on ceasing to act as office holder pursuant to the proposed block transfer order; and
37. Where the Act or the Rules require the substitution of the Applicant to be advertised, the Applicant shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in relation to each of the estates shall be placed in the London Gazette containing notification of the following matters:
 - a) the substitution of the Applicant and details of the substitution;
 - b) the fact that the creditors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the order made;
 - c) in the case of each bankruptcy and liquidation, that:
 - i. the costs of complying with a request of the committee or creditor for an account of the Applicant's administration should be an expense of the insolvency proceedings;



- ii. the fact that the creditors have the right to object and make representations to the Secretary of State in respect of the Applicant's release within 28 days after the notice has been advertised,
- iii. the fact that the Applicant will be entitled to apply to the Secretary of State for his release within 42 days after the notice has been advertised.
(currently estimated at £520 including VAT for court case)
38. The costs of the Application/be apportioned equally between each of the estates identified in Schedules 1 to 23 hereto and each of the said estates shall bear an equal proportion of the costs.
39. In no case shall the amount charged to any estate in respect of the costs exceed 10 per cent of the aggregate of available funds and the value of the immediately realisable assets in that estate.
