Directors' Report For the year ended 31 December 2018

The Directors present the annual report and the audited financial statements for the year ended 31 December 2018.

This Directors' report has been prepared in accordance with the provisions applicable to small companies entitled to the small companies' exemption.

Principal activities

The principal activity of the Company during the year was to act as an investment company in the property sector. The future plans of the Company are to continue to act as an investment company in the property sector.

Qualifying third party indemnity provisions

The Directors of Community Solutions for Primary Care (Barnsley) Limited have qualifying third party indemnity provisions put in place through other companies of which they are also a Director.

Dividends

The Company paid a dividend of £412,000 during the year (2017: £165,000).

Going concern

The Directors have reviewed the future liquidity requirements and have considered the cash flow forecasts of the Company. The Company is reliant on the monies received from its subsidiary companies. The Directors have a reasonable expectation that its subsidiary undertakings will have adequate resources to meet their obligations.

The Directors have a reasonable expectation that the Company has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

Directors' responsibilities statement

The Directors are responsible for preparing the annual report and the financial statements in accordance with applicable law and regulations.

Company law requires the Directors to prepare financial statements for each financial year. Opinion

Principal Accounting Policies For the year ended 31 December 2018

Community Solutions for Primary Care (Barnsley) Limited is incorporated in England and Wales. The registered office is 1 Aire Street, Office 4:10, Leeds LS1 4PR.

The principal accounting policies applied in the preparation of these financial statements are set out below.

Basis of preparation

The financial statements have been prepared in accordance with FRS 102 the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland.

The functional currency is pounds sterling and rounded to the nearest £'000.

Financial liabilities and equity

Financial liabilities and equity are classified according to the substance of the financial instrument's contractual obligations, rather than the financial instrument's legal form.

Investments

Fixed asset investments are recorded at cost less amounts written off or provided to reflect impairment loss.

Joint ventures

An entity is treated as a joint venture where the group holds a long term interest and shares under a contractual agreement.

Dividends

Equity dividends are recognised when they become legally payable. There is no requirement to pay dividends unless approved by the shareholders by way of written resolution where there is sufficient cash to meet current liabilities, and without detriment to senior debt covenants, if applicable.

Interest receivable and payable

Interest is recognised on an effective interest basis in the period in which it accrues.
