

AND UPON reading the First Witness Statement of Paul Mallatratt with Exhibit PM1 dated 2 December 2020

#### IT IS ORDERED THAT:

- The County Court and Insolvency Service Adjudicator's Office cases listed in Part 1 of Schedule 1 (attached to this order) be transferred to the High Court of Justice, Business and Property Courts in Manchester, Insolvency and Companies List (ChD) for the purpose only of making this order.
- 2 Immediately upon this order taking effect, the County Court and Insolvency Service Adjudicator's Office cases listed in Part 1 of Schedule 1 be transferred back to their respective County Courts and the Insolvency Service Adjudicator's Office.
- 3 Paul Mallatratt be removed from office in respect of each of the cases listed in Parts 2 and 4 of Schedule 1 and Part 1 of Schedule 2.
- 4 Louise Freestone be removed from office in respect of each of the cases listed in Parts 3 and 4 of Schedule 1 and Part 2 of Schedule 2.
- 5 Thomas James Grummitt be appointed as sole replacement officeholder in respect of each of the cases listed in Parts 2, 3 and 4 of Schedule 1 from the date of this order.
- 6 Thomas James Grummitt be appointed as joint replacement officeholder in respect of each of the cases listed in Schedule 2 from the date of this order.
- 7 The creditors in each of the cases listed in Schedules 1 and 2 be notified of this order by advertisement in the London Gazette within 21 days of the date of this order and at the time of the next statutory reporting requirement for each case.
- 8 Any creditor in respect of any of the companies or persons listed in Schedules 1 and 2 who has an objection to this order shall have 21 days from the date of the advertisement in accordance with the preceding paragraph to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the cases listed in Schedules 1 and 2 until further or other order by the court.
- 9 The Applicants shall give notice to the Secretary of State for Business, Energy and Industrial Strategy in respect of the administrations, liquidations and bankruptcies listed in Schedules 1 and 2, and to the Registrar of Companies in respect of the administrations and liquidations listed in Schedules 1 and 2, of the terms of this order as soon as reasonably practicable.
