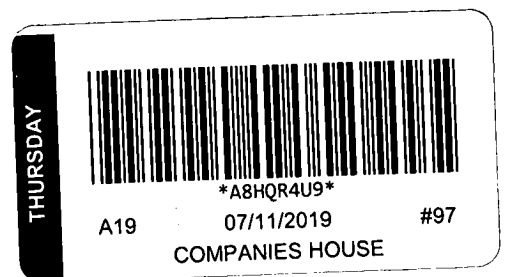

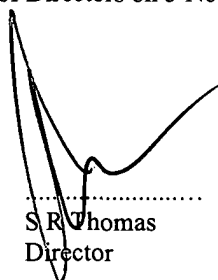
The financial statements have been prepared and delivered in accordance with the provisions applicable to companies subject to the small companies regime.
