**Principal activity**

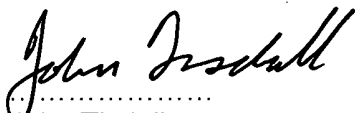
The Company did not trade during the year to 31 December 2015 and was dormant within the meaning of Section 1169 of the Companies Act 2006.
