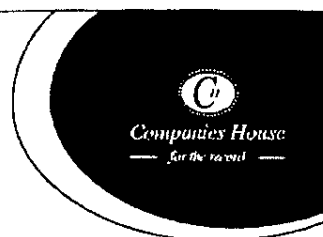



Short particulars
