1 Accounting Policies

Basis of measurement and preparation of accounts

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities effective April 2008.

2 Fixed assets Investments

Note : investment/long-term creditor: the Company has a long-term loan of \$300,000 which is effectively secured against a related investment in EnQii PLC, which is contingent on EnQii's future performance. The directors of the Company have only valued the investment at the loan balance.
