FOR THE YEAR ENDED 31 AUGUST 2019

The Trustees who are also directors of the charity for the purpose of the Companies Act 2006, present their report and financial statements for the year ended 31 August 2019.

The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the financial statements and comply with the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016)

Objectives and activities

The main objectives of the charity are as follows:

- To assist at all times the institution in Israel, known internationally as Boys Town Jerusalem or locally as Kiryat Noar located in Bayit Vegan Jerusalem, which is under the governance of Dean Rabbi Moshe Linchner.
- To appeal for, solicit, and accept, donations for the purpose of the charity.
- . To raise awareness of the work and needs of Boys Town Jerusalem across the UK Jewish community.

The School

Boys Town Jerusalem is a residential school encompassing grades 7-12 and a two-year College of Applied Engineering. The curriculum, which is certified by Israel's Ministry of Education, combines the timeless values of Jewish heritage and advanced technology. British Friends of Boys Town Jerusalem helps support of all who share its vision of turning otherwise disadvantaged Israeli youth into productive citizens of tomorrow.

More than 75% of the students come from economically disadvantaged backgrounds and the vast majority require financial assistance in order to receive a first-class secular education, broad Jewish curriculum, full residential boarding facilities, three freshly-prepared meals each day, dedicated counselling & special needs services, one-to-one tutoring support, & extra-curricular programme spanning educational, sporting, volunteering, social and communal activities.

Activities

During the period to 31st August 2019, the charity held a number of fundraising events including:

- · Inaugural Golf Day held on June 2nd 2019 at The Grove Hotel and Golf course, attended by 50 guests.
- The 12th Annual Choral Festival took place at the Artsdepot in Finchley, London. 11 Jewish Primary Schools participated and more than 750 quests attended the event, including the Mayor of Barnet.
- 30 people ran for Boys Town Jerusalem at the Annual Maccabi GB Community Fun Run in June.
- 5 boys participated in the 13 for 13 Bar Mitzvah project, raising money for pupils celebrating their Bar Mitzvah at Boys Town Jerusalem.

These and other smaller events and other public relations activity during the year served to widen the public's awareness of the charity.

Achievements & Performance

Over 7,500 boys have graduated from Boys Town, Jerusalem since it opened in 1949 and, despite their disadvantaged backgrounds, these young men have gone on to make major contributions to their communities and the State of Israel. Academic results for the school significantly exceed the national average, with a 92% pass rate in Israel's Bagrut exams compared to the national average of 70%.

Boys Town Jerusalem has transformed the lives of thousands of young Israelis, giving them and the state of Israel a brighter future. Today, 950 boys attend this remarkable school. The graduates continue to be best placed to contribute back to Israeli society.

The charitable work of British Friends of Boys Town Jerusalem supports Israel's most vulnerable children by providing them with the self belief and skills they require to benefit from a constructive future.

The notable milestones achieved during this financial year were

- Raising a total of over £301,376 delivering £149,635 in funds for Boys Town Jerusalem
- · Reducing overheads which supported fundraising activities by over £25,000 compared to the previous
- · Launch of the "Patron" and "Friends" program offering valuable and loyal donors a range of engaging touch points with Boys Town Jerusalem. Signing up four patrons at £5,000 each by end of the year.
- · Launch of a "Monthly Giving" initiative for dedicated donors at a range of monthly price points, from £1 to £59 per month, which provides the charity with secure regular income as well as highlighting a core of engaged donors to the trustees. By the end of the year, the charity had signed up 12 monthly donors.
- · Launch of the "Legacy" programme, targeting gifts left in estates through wills. The charity benefited from a legacy in excess of £100,000 left by an estate of a generous benenefactor for which the trustees and Boys Town Jerusalem are most grateful.
- . Donation received of \$7,500 as the first annual instalment of a 3 year commitment by the Kirsh Foundation

Whilst the trustees are satisfied with the gross income raised and the profile generated for the charity received during the reporting period, concerns remained during the year with regards with the overall net contribution to Boys Town Jerusalem as a percentage of gross income raised due to the level of overheads incurred, especially on a pro-forma basis after stripping out the exceptional legacy gift received.

Public benefit

British Friends of Boys Town Jerusalem is to benefit economically deprived youth in Israel to give then a hope and a future by practical support from donations made by individuals and organisations worldwide.

The Trustees have considered the objectives and activities and concluded:

- That the aims of the organisation continue to be charitable.
- · That the aims and the work done give identifiable benefits to the charitable sector and both indirectly and directly to individuals in need.
- · That the benefits are for the public, are not unreasonably restricted in any way and certainly not by ability
- · That there is no detrimental or harm form the aims or activities.

The Trustees have paid due regard to guidance issued by the Charity Commission in deciding what activities the Charity should undertake.

Plans for future periods

The trustees evaluated throughout the year ways to reduce its cost base, and have taken action to ensure from January 2020 the UK charity will be run without any paid staff and its central administrative office in Alexander House, Finchley Road. The trustees would like to thank the London School of Jewish Studies for agreeing to use their offices as the charity's registered and correspondence address.

The trustees are confident that a new approach for fundraising will be more effective to meet the UK's charitable objectives than in recent years. Boys Town Jerusalem's fundraising has for a long time been a global effort, with national charities soliciting donations in the United States and Canada, and during this year fund raising commenced in Australia. The UK trustees believe that by deploying a global and centralised framework based at the school campus in Jerusalem and led by the school's International Development Director, support activities can be more efficiently undertaken by combining marketing communications across the different nations and through leveraging functional expertise such as unique skills needed to reach out to charitable foundations.

Boys Town Jerusalem appointed Joshua Churney in December 2019 as the UK Development Coordinator, with responsibility to support charitable activities in the UK working alongside the trustees. Joshua was raised in London before serving in the IDF in 2008 and making aliyah. The trustees regard its aims will be achieved better with the UK Development Coordinator working everyday within the school's charitable and educational environment and benefiting from combining his efforts alongside a wider fundraising team at the school.

Reserves policy

The policy is to maintain the equivalent of one quarter of budgeted operating expenditure as unrestricted reserves, in order to cover shortfalls and allow trustees sufficient time to take any required actions. The view of reserves has been influenced by the irregular cash flow, as donations tend to be anchored around festivals in the lunar (Jewish) calendar and the fact that some months have posted negative cash flow in the past.

Staff costs

At the start of the reporting period, there were 3 employees. At the start of the end of the reporting period, there were 2 employees. No employees received employee benefits of more than £60,000.

Trustee expenses

No trustee expenses were incurred during the reporting period.

Structure, governance and management

In this financial year the Executive Development Director based at Alexander House together with the trustees were responsible for coordinating various activities such as; fundraising, marketing communications, and visits to Boys Town Jerusalem with the International Development Director, who is based at the school's campus in Jerusalem. During the financial year, trustees delegated day to day running of the charity to the Executive Development Director, who was a full time employee. As described above, the trustees will continue with their roles, but day to day running of the charity will be led by the UK Development Coordinator based at the school in Jerusalem.

The trustees are divided into two subcommittees; the Finance Committee broadly responsible for accounting, reporting & fund management of the charity; the Events Committee broadly responsible for the planning & execution of events. All trustees are tasked with fund raising.

The Chairman is responsible for setting the agenda for trustee meetings, ensuring trustees receive accurate, timely and clear information, keeping track of the contribution of individual trustees, and acting as the lead representative for presenting the charity externally. Whilst all trustees are responsible for setting the charity's direction and strategy, the chairman's role is to gain consensus for any agreed policy. In the event a unanimous decision is not reached amongst trustees, the Chairman's communicates the final agreed decision.

The trustees believe that at all times there should be a minimum of three trustees and therefore a minimum of three board directors. Any of the existing trustees have the opportunity to put forward prospective trustees for consideration. Prospective trustees have an interview and are then invited to attend a meeting as an observer, there is then a further opportunity for discussion before the invitation to join the board. The final decision on whether a trustee should be appointed to the board remains with the Chairman.

British Friends of Boys Town Jerusalem is a company limited by guarantee without share capital. Its governance is determined by the memorandum and articles of association dated August 2003.

The trustees have taken into account the Charity's commission's public benefit guidance in the decision making and operation of British Friends of Boys Town Jerusalem. No significant departure from the guidance has been noted.

The Trustees has assessed the major risks to which the Charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks.

1 Accounting policies

Charity information

British Friends of Boys Town Jerusalem is a private company limited by guarantee incorporated in England and Wales. The registered office is Schaller House, 44a Albert Road, London, NW4 2SJ.

1.1 Accounting convention

The financial statements have been prepared in accordance with the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The Charity is a Public Benefit Entity as defined by FRS 102.

The Charity has taken advantage of the provisions in the SORP for charities applying FRS 102 Update Bulletin 1 not to prepare a Statement of Cash Flows.

The financial statements are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

1.2 Going concern

At the time of approving the financial statements, the Trustees have a reasonable expectation that the Charity has adequate resources to continue in operational existence for the foreseeable future. Thus the Trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of their charitable objectives unless the funds have been designated for other purposes.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

Endowment funds are subject to specific conditions by donors that the capital must be maintained by the Charity.

1.4 Incoming resources

Income is recognised when the Charity is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Charity has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Turnover is measured at the fair value of the consideration received or receivable and represents amounts receivable for goods and services provided in the normal course of business, net of discounts, VAT and other sales related taxes.

1.5 Financial instruments

The Charity has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the Charity's balance sheet when the Charity becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

Basic financial liabilities

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method.

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

Derecognition of financial liabilities

Financial liabilities are derecognised when the Charity's contractual obligations expire or are discharged or cancelled.

2 Critical accounting estimates and judgements

In the application of the Charity's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.
