**3. Directors' benefits: advances, credit and guarantees**

**Advances**

The Directors loan account is repayable on demand and interest is charged on overdrawn balances exceeding £10,000 at the official HMRC rates.

At 1 April 2020, the balance was £23,533. During the year, £46,941 was advanced to the director, and £37,393 was repaid by the director. The balance at 31 March 2021 was £33,081.

At 1 April 2019, the balance was £110,099. During the year, £4,545 was advanced to the director, and £91,111 was repaid by the director. The balance at 31 March 2020 was £23,533.
