1 ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Report Standard for Smaller Entities (effective June 2002).

Grants

Grants credited to unrestricted funds are to be used at the discretion of the Association in furtherance of its objectives.

A director of Community Development Cymru, Brian Thirsk, receives expenses from the company for travelling costs incurred in his role as it's representative on the Communities First Support Network ("CFSN"). These expenses are then reimbursed to Community Development Cymru by CFSN.
