Almost all the funds in the current account are committed for improvement work, £5,500 transferred from the Savings account is ready to purchase land for a mini Hydro scheme, and much of the rest is grant monies We have no liabilities Please see the separate sheet for the breakdown of income and expenditure

ANNUAL REPORT 31 October 2011

This is the eighth annual report of Coetir Mynydd and covers the period 1 November 2010 to 31 October 2011 During this period the business of the company was directed by the Board which comprised: Martin Daws, Bryan Dickinson, Einlir Frodsham (Chair), Mark Goddard, Gwen Griffiths, Sharon Sweeny, Jenny Wong (Secretary) and Mike Vitkovitch assisted by two officers, Mike Yates (Treasurer) and Bryn Williams.

The year was a busy one with several projects underway and new ones being planned

Porestry Commission Pathfinder

The work on the two Forestry Commission Pathfinder projects (consultation on the Parc yr Ocar management plan review, and the Parc yr Bwlch consultation) has been completed and short reports prepared for Forestry Commission. These projects were funded by the "Better Woodlands for Wales" grant programme, which was withdrawn by the Minister for Rural Affairs in August 2011. We have assurances from the Forestry Commission that they remain committed to follow up to these consultations.

Parc yr Ocar management plan

The Parc yr Ocar consultation fed into the revision of the management plan, which resulted in a new 5 year BWW grant from the Forestry Commission As mentioned above this programme is now closed and this is the last time we will get funding in this way. The BWW grant will provide small annual payments for the permissive footpath and a contribution to control of invasive species and safety work.

We were successful in the bid to the Community Wildlife programme of the Big Lottery Fund. This gives us £8,000 towards the cost of upgrading the permissive footpath. The plan was to use this opportunity to provide work experience and volunteering for young people in the village However, it has proved difficult to find a suitable project manager for the project and by the year end work had not commenced. There are now firm agreements with a contractor to undertake this work over the next few months.

Parc y Bwlch - Consultation

The community consultations in Tregarth and Rhiwlas were run as activities in the Youth Clubs from November 2010 and completed in May/June 2011 The sessions were delivered by Dyfodol with the support of WTA Education Services (who helped

with the one in Mynydd a few years ago) and hosted by Gwynedd Youth Services. Two reports were prepared and presented to the Forestry Commission for consideration in the preparation of a Design Plan for Parc y Bwich. The design plan mostly contains the plans for felling and replanting but also indicates where footpaths are needed etc. The ball is now in the Forestry Commission's court and they have promised to host a public meeting to present the draft Design plan and to consult further on the future for Parc y Bwich. We hope this will take place in the next few months.

Micro-hydro

We obtained a grant for £5,000 from the Waterloo Foundation to pay for a full feasibility study for the micro-hydro. A report was commissioned from Dulas and completed in late 2011 and is available on the website.

Himalayan balsam


It takes several years of clearance to to successfully get rid of Himalayan balsam. We started to clear the land around the village in 2009 under the CCW funded Biodiversity project. This year a follow pick was organised in July to revisit the sites with the plant last year. It was very encouraging to see that there were only a few plants where previously there had been dense thickets. Thanks to everyone who helped pick — do remember we will need to repeat this again next year but we are winning!

Bird ringing project

This project ended in April 2011 but we have yet to see a final report or indeed see any of the results other than Lucy Baird's thesis. This is very disappointing but several people have continued to keep records of birds ringed during the project and Chris Allen is compiling these in the hope we will be able to create our own maps showing how the bird's move around the village.

Extension to Parc yr Ocar

We completed the purchase of a small extension to Parc yr Ocar during the year. This adds around an acre to our property and includes a suitable site for the hydro turbine house. Many thanks to George Stevens for giving us the opportunity to increase the area we can manage for the benefit of the whole community.
