

#### 1. ACCOUNTING POLICIES

##### 1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards

The company is itself a subsidiary company and is exempt from the requirement to prepare group accounts by virtue of section 400 of the Companies Act 2006. These financial statements therefore present information about the company as an individual undertaking and not about its group.

##### 1.2 Going concern

As referred to in note 6 the financing arrangements of the company have been the subject of enquiries by HM Revenue & Customs, with a potential liability of £1,974,696 payable. Whilst a decision has ruled in favour of HM Revenue & Customs the directors are confident of winning an appeal lodged at the Upper Tier Tribunal. It is on this basis that it is deemed appropriate that these accounts are prepared on a going concern basis.

##### 1.3 Cash flow

The company, being a subsidiary undertaking where 90% or more of the voting rights are controlled within the group whose consolidated financial statements are publicly available, is exempt from the requirement to draw up a cash flow statement in accordance with FRS 1.

##### 1.4 Investments

Investments held as fixed assets are shown at cost less provision for impairment.

#### 6. CONTINGENT LIABILITIES

The financing arrangements adopted by the company have been the subject of enquiries by HM Revenue & Customs. These have now been completed and the level of taxable profits of the company for the year ended 31 March 2004 and 31 March 2005 is disputed. The amount of Corporation tax and interest on overdue tax payable should HM Revenue and Customs be successful in their contentions is £1,974,696.

A decision on a similar case by the First Tier Tribunal on the 21 December 2011 found in favour of HM Revenue & Customs, but the directors have taken further legal advice on this matter and the company has appealed against the decision. Furthermore the directors are confident that the appeal will be successful and it is on this basis they continue to consider that no liability should arise.

There are cross guarantees in respect of bank borrowings of the parent undertaking, City & General Securities Limited. The borrowings are secured by a fixed and floating charge over the property and assets of Finitum One Limited. At 31 March 2012 those borrowings amounted to £16,150,452.

#### 7. RELATED PARTY TRANSACTIONS

The company has taken advantage of the exemption under Section 3c of Financial Reporting Standard No 8 'Related Party Disclosures' (FRS 8) and has not disclosed any intra group related party transactions.

The largest and smallest group into which the company is consolidated is City & General Securities Limited which is registered in England and Wales. The company is ultimately controlled by the directors.
