

**REPORT OF THE INDEPENDENT AUDITORS TO THE MEMBERS OF
THE LAURELS MANAGEMENT (IPSWICH) LIMITED**

We have audited the financial statements of The Laurels Management (Ipswich) Limited for the year ended 31st October 2005 on pages five to eight.
