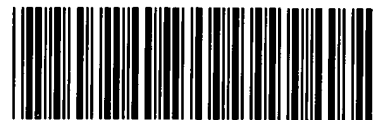

### **Directors' Report For the year ended 31 March 2018**

The directors present their annual report and the unaudited financial statements for the year ended 31 March 2018.

This directors' report has been prepared in accordance with the provisions applicable to small companies entitled to the small companies' exemption.

With effect from 8 August 2018 the Company's name changed from Sandwell LIFT (Midco) (No.3) Limited to Sandwell Midco 3 Limited.

#### **Principal activities**

The company has been dormant, as defined in Section 1169 of the Companies Act 2006, throughout the year ended 31 March 2018.

#### **Going concern**

The directors have reviewed the future liquidity requirements and have considered the cash flow forecasts of the company. Based on this review and the future business prospects of the company, despite the current economic conditions the directors believe the company will be able to meet its liabilities as they fall due.

Having regard to the above and after making enquiries, the directors have a reasonable expectation that the company has adequate resources to continue in operational existence for the foreseeable future. Accordingly, they continue to adopt the going concern basis in preparing the annual report and accounts.

#### **Result and dividends**

There has been no trading activity in the current or prior year and consequently the company has made no profit or a loss. Therefore no statement of comprehensive income has been prepared.

#### **Directors' responsibilities statement**

### **Principal Accounting Policies For the year ended 31 March 2018**

Sandwell Midco 3 Limited is incorporated in England and Wales. The registered office is 15th Floor Cobalt Square, 83-85 Hagley Road, Birmingham, B16 8QG.

The principal accounting policies applied in the preparation of these financial statements are set out below.

#### **Basis of preparation**

The financial statements have been prepared in accordance with FRS 102 the Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland.

The functional currency is pounds sterling and rounded to the nearest £.

#### **Basis of consolidation**

Consolidated financial statements have not been prepared for the company and its subsidiaries under the exemption granted by Section 398 of the Companies Act 2006. Accordingly, these financial statements present information about the company and not about its group.

#### **Financial liabilities and equity**

Financial liabilities and equity are classified according to the substance of the financial instrument's contractual obligations, rather than the financial instrument's legal form.

#### **Investments**

Investments held as fixed assets are stated at cost less provision for any impairment in value.

#### 6. Ultimate parent company and controlling party

The company is a wholly owned subsidiary of Sandwell Estates Partnership Limited (formerly Sandwell LIFT Company Limited), a company registered in England and Wales. As at 31 March 2018, Sandwell Estates Partnership Limited was owned by Primary Plus Holdings Limited (60%) and Community Health Partnerships Limited (40%), which are both registered in England and Wales.

#### 7. Related party transactions

The company had no related party transactions during the current or prior year.
