Principal activity and review of business

The principal activity of the Company is that of General Partner of two private equity limited partnerships. The Company was incorporated on 30 October 2003, with share capital of 1 £1 ordinary share issued at par, as Actis Investments Limited and changed its name to Actis Africa GP Limited on 23 June 2004. Its registered office is 2 More London Riverside, London, SE1 2JT.

The directors have no direct interest in the shares of the Company. However, by virtue of Paul Owers' position as member of Actis LLP, he had an indirect interest in the entire share capital of the Company and the Actis group.

Basis of preparation

The financial statements have been prepared under the historical cost convention, in accordance with applicable accounting standards

Functional currency

Items included in the financial statements are measured using the currency of the primary economic environment in which the entity operates ("the functional currency") US dollar is the company's functional and presentation currency

Foreign currencies

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction Monetary assets and liabilities denominated in foreign currencies are retranslated at the rate of exchange ruling at the balance sheet date All gains or losses on translation are taken to the profit and loss account
