Further to my appointment as Joint Administrator of the Group, I attach a copy of my statement of proposals in accordance with paragraph 49 of Schedule B1 to the Insolvency Act 1986

As you will note from the proposals, there is no prospect of any funds becoming available to unsecured creditors other than by virtue of the Prescribed Part. As a consequence, I do not propose to summon a meeting of creditors. If, however, creditors whose debts amount to at least 10% of total debts of a company in the Group makes a request in the prescribed form within 8 business days of these proposals being made available to creditors, a meeting will be held. A copy of the prescribed form (Form 221B) is attached in case you wish to request a meeting.

I would draw your attention to the provisions of Rule 237 of the Insolvency Rules 1986 which provide that if a meeting is requested, it will only be held if the expenses of summoning and holding such a meeting are paid by the creditor or creditors making the request and if security is first deposited with me for payment. The meeting may subsequently resolve that the expenses of summoning and holding the meeting are paid out of the assets of the company as an expense of the administration.

In the event that a meeting is not held, the proposals will be deemed to be accepted. The Joint Administrators' remuneration, Category 2 disbursements and unpaid pre-administration costs incurred will be agreed with the secured creditors and the preferential creditors in accordance with the provisions of Rule 2106(5A) and Rule 267A of the Insolvency Rules 1986.

## 1. Introduction, background and circumstances giving rise to the appointments

### Introduction

On 30 June 2011 the Companies entered Administration and T A Jack and S Allport were appointed to act as Joint Administrators.

This document, including its appendices, constitutes the Joint Administrators' statement of proposals to creditors pursuant to paragraph 49 of Schedule B1 to the Act and Rule 2.33 of the Rules for T J Hughes Limited, T J Hughes (Holdings) Company Limited, T J Hughes (Investments) Limited, T J Hughes (Properties) Company Limited (all in Administration).

Certain statutory information relating to the Companies and the appointments of the Joint Administrators is provided at Appendix A.

### Background


At the time of the appointments, the Group was regarded as one of the largest department stores in the UK, trading from 56 stores nationally with c. 3,500 employees in total. It traded as a discount retailer selling products with prices up to 70% below RRP.

The Group's head office and management functions were operated from leasehold premises at Hughes House, Liverpool, where 129 head office staff were located. The Group also had operations at two warehouses in the Liverpool area that held minimal stock.

The original business was founded in 1912, on London Road in Liverpool. The company floated on the London Stock Exchange in 1992, and was taken private in 2000 by JJB Limited before being acquired by PPM Capital in 2003. The Group refinanced with Burdale via a £20m stock and loan facility in early March 2011 and was subsequently acquired by Endless LLP, a turnaround investor. The Group has had several senior management changes in the past nine months to support an attempted turnaround.

Prior to Endless LLP's investment, in March trade credit insurance cover for suppliers was significantly reduced, which together with continued poor trading performance and increased cash requirements resulted in the Group seeking additional funding. In April 2011, additional funding of £10m was provided to the Group by Endless LLP to support the business whilst a turnaround plan was developed. Trading continued to be challenging and like for like retail sales were significantly below prior year levels resulting in an extensive cost reduction programme as part of a long term turnaround plan.

A summary of the Wider Group structure at the date of the appointments is presented below



The recent financial results for the Group, together with further details of its operations, are outlined below

#### Trading history

##### *T J Hughes (Holdings) Company Limited*

Holdings is a non-trading holding company. It does not produce its own individual profit and loss accounts, and reports the consolidated position for the Group in its financial statements. A summary of recent Group results is shown below.

**Section 1 Introduction, background and circumstances giving rise to the appointments**

**T J Hughes Limited**

TJH is the main trading company within the Group and its principal activity is as a discount department store. It is the sole employer in the Group, employing all of the store and head office staff and holds 57 leases of the 59 lease portfolio operated by the Group.

The table below summarises recent trading results relating to TJH.

Draft management accounts for TJH for the 18 weeks to 4 June 2011 indicate a net loss of £10.1m from a turnover of £69.1 million. Whilst losses for this period were not unusual given seasonal trends, the magnitude reflected the challenging market conditions and issues regarding the mix of stock within the business.

**T J Hughes (Investments) Limited**

Investments' principal activity is that of an investment company. It directly holds 100% of the TJH shares.

### **Circumstances Giving Rise to the Appointment of the Administrators**

In the past 12 months, trading conditions for the Group have been extremely difficult. The Christmas 2010 trading results were extremely poor and the Group suffered large losses (£6.3m) for the year ended January 2011. This was compounded by the adverse cash flow impact of large stock holdings, the profit impact of subsequent stock reduction initiatives, and ultimately the withdrawal of supplier credit insurance in recent months.

Prior to both the re-finance and acquisition by Endless LLP, credit insurers were already in discussions with the Group regarding the reduction of available supplier credit insurance, based on the Group's expected outturn for the year ended January 2011.

In March 2011, a refinancing of the business with Burdale was achieved via a £20m stock and loan facility.

Despite this, later in March a number of credit insurers significantly reduced, and eventually withdrew credit insurance cover to the Group's suppliers, which had a material impact on the Group's trading relationships with those suppliers.

As a result, the Group's future working capital requirements increased significantly and at this point the Board contacted Endless LLP to seek additional funding to enable it to continue to trade. Endless LLP agreed to support the business whilst a turnaround plan was constructed.

As part of the turnaround plan, Anthony Solomon and David Luper were introduced to the business, as Chairman and Director respectively, to assist in the restructuring of the Group. We understand it was the intentions of the new directors to inject additional cash into the business, however, this was never formally agreed. In June both Mr Solomon and Mr Luper resigned from the business and at this point, Robert Lister was appointed as sole director of the Group.

Despite the introduction of significant turnaround funding the Group continued to experience poor trading results, and significant cash flow and creditor pressure. On 24 June 2011 a winding up petition was lodged against TJH by a trade creditor and bank accounts were frozen. At this stage the Group needed substantial additional working capital funding to carry on trading, with an estimated additional funding requirement of up to £20m to trade to 31 December 2011 as a result of the withdrawal of credit insurance and other working capital needs.

As a result, the Group concluded a turnaround of the business was not viable as the level of funding needed was not supportable as a result of historic and ongoing losses. As a consequence, the Director of the Group decided that to protect the interests of all creditors it was necessary to place the Group into Administration.

Due to the winding up petition, the Director was unable to formally file a Notice of Intention to appoint Administrators at Court and accordingly invited the qualifying floating chargeholder to do so.

On 28 June 2011, the qualifying floating chargeholder lodged a Notice of Intention to Appoint Administrators over TJH. Following this, Thomas Andrew Jack and Simon Allport were appointed as Joint Administrators of the Companies on 30 June 2011 under the provisions of paragraph 14 of schedule B1 of the Act.

At the request of the Group's shareholders and Director, Ernst & Young LLP undertook work in the period immediately prior to insolvency to advise on strategic options and to undertake contingency planning. Further detail of the work undertaken in the pre-appointment period is provided at section six of this report.

At the date of appointment Burdale, the first ranking secured creditor, had total secured lending of £13.6m, and Endless LLP had second ranking secured debts of £10.2m. Following the appointments of the Joint Administrators, on 6 July 2011 Endless LLP assigned its rights and security to the second ranking secured debt for an undisclosed sum to GA Europe 300 Limited, a company associated with GAG, a retail turnaround investor and stock realisation specialist.

## 2. Purpose, conduct and end of Administrations

### Purpose of the Administrations

The purpose of an Administration is to achieve one of three objectives:

- a. To rescue the company as a going concern
- b. To achieve a better result for the company's creditors as a whole than would be likely if the company were wound up (without first being in Administration)
- c. To realise property in order to make a distribution to one or more secured or preferential creditors

Insolvency legislation provides that objective (a) should be pursued unless it is not reasonably practicable to do so or if objective (b) would achieve a better result for the company's creditors as a whole. Objective (c) may only be pursued if it is not reasonably practicable to achieve either objective (a) or (b) and can be pursued without unnecessarily harming the interests of the creditors of the company as a whole.

Objective (a) cannot be achieved in this matter for the following reasons:

- The Group is heavily loss making and it is unlikely that profitability can be returned in the short to medium term, particularly given the high fixed cost base of the business associated with its current store portfolio and the challenging state of the retail market, and
- A significant proportion of the stock is subject to ROT claims, and the support of the suppliers (including credit terms) is likely to be severely restricted post insolvency, giving a substantial funding requirement for the Group to continue to trade as a going concern

The Joint Administrators have therefore pursued objective (b) to achieve a better result for the Group's creditors as a whole than would be likely if the companies in the Group were wound up (without first being in Administration), rather than objective (a). The reasons for this are outlined below

- If the Group were to be wound up, realisations from stock would be significantly reduced due to restricted trading conditions with stock subject to valid ROT claims being returned to suppliers and any recoveries from the remaining unencumbered stock being disposed of in bulk at very low realisable values;
- Realisations from the Group's property portfolio are likely to be enhanced if they are disposed of whilst the Group is still trading and these premises are therefore occupied and in use as retail outlets, and
- The possibility exists of successfully transferring employment contracts and leasehold interests to potential purchasers in order to reduce both preferential and non-preferential claims.

## Conduct of the Administration

### *Trading*

#### *Initial activities following appointment*

Immediately upon appointment, the Joint Administrators' staff attended all 56 stores and the Group's two Liverpool distribution centres. During these visits, employees were addressed and measures were taken to protect the Group's assets.

A central team was also located at the Group's head office in Liverpool and a number of actions were taken to facilitate an ongoing trading strategy including a revision to policies regarding customer orders, credit notes, gift vouchers, returns and deposit procedures and the suspension of online orders

#### *Trading sales*

Following their appointment, the Joint Administrators sought to maximise the realisable value of stock in hand (estimated net book value of £38m) by enabling the business to continue to trade in Administration whilst pursuing a going concern sale of all or part of the Group's business and assets.

Notwithstanding this, it quickly became apparent that any such sale(s) would likely require a number of weeks to complete. In addition, there was limited senior management in the business following the recent changes. On 6 July 2011, following GA Europe 300 Limited's acquisition of the second ranking secured debt, the Joint Administrators engaged specialist retail agents GAG to assist and advise on the realisation of TJH's stock. Since this time, extensive marketing and promotional activities have been undertaken and additional stock has been purchased to boost overall realisations from the Group's store portfolio

At the date of appointment there were 22 businesses operating from within the Group's stores under concession agreements, providing additional income to the Group of c. £88,000 per week. The Joint Administrators sought to engage directly with these parties soon after their appointment with a view to agreeing ongoing trading terms. Terms were agreed with the majority (18) of the concessionaires, who have continued to trade from the stores, with the remaining four choosing to exit.

Since the date of appointment, for the period to 10 August 2011 we have achieved retail sales (net of VAT) totalling £35.6m and an additional £0.6m of concession income. This is stated before trading costs, any valid ROT claims and taxation

All other Group companies in Administration are non-trading and as such no sales have been achieved

#### *Trading costs*

Following our appointment, the Joint Administrators pro-actively engaged with several key suppliers (including but not limited to IT suppliers, hauliers, cash collection agents, maintenance contractors and merchant services providers), in order to ensure the business continued to trade with minimal disruption

Additional stock owned by TJH but in the possession of third parties has been released and brought into stores.

We continue to liaise with suppliers, landlords, employees and other stakeholders to mitigate trading costs and maximise the outcome from continued trading activities

### **Sale of business**

Immediately upon appointment, the Joint Administrators began a marketing process for the disposal of the Group's business and assets on a going concern basis. As part of a dual track process the Joint Administrators also engaged Jones Lang LaSalle, property consultants, to market the Group's leasehold property portfolio.

Following the receipt of signed non-disclosure agreements, dialogue with a broad spectrum of interested parties was entered into and comprehensive financial, operational, property and legal information was made available. In total, the Joint Administrators have to date made contact with 156 interested parties.

#### *Sale of part of the business as a going concern*

On 29 July 2011, the Joint Administrators entered into an agreement to sell the business, assets and property rights of the Sheffield, Glasgow, Eastbourne and London Road, Liverpool stores to LHR. This transaction was completed on 8 August 2011, and included the transfer of all employees attributable to these stores.

Total consideration was £1,650,337 of which £900,000 was received on completion and the balance of £750,337 deferred, against which we have taken security over unencumbered assets.

In addition, the transaction afforded TJH the right to occupy the Group's head office at London Road, Liverpool up to 15 September 2011, reducing costs in the Administration by approximately £100,000. As part of this transaction, 442 jobs were transferred to LHR, also reducing the value of preferential and non-preferential claims in the Administration of TJH.

On 10 August 2011, a further two stores were sold as a going concern to LHR. Total consideration was £286,909, all payable on completion. As part of the transaction an additional 134 employees have transferred to LHR.

We are continuing in negotiations with a number of interested parties for the sale of further stores as a going concern.

### **Property**

At the date of appointment, the Group held leasehold interest in 59 properties, a small car park in Liverpool and an annex to the Bradford store. The majority of the leases to the retail properties are held by TJH with two being held by Properties.

#### *Trading stores*

Upon our appointment, TJH traded from 56 leasehold stores across the United Kingdom. One store (Perry Barr) was already in the process of being closed by management and was vacated at the date of appointment. All other stores continued to trade in Administration.

In addition to the sale of the leasehold interests to LHR, on 29 July 2011 we entered into an agreement to surrender the lease of the Lichfield store to its landlord for consideration of £300,000.

We continue to negotiate with landlords for the surrender of further leasehold interests.

As at 11 August 2011 the closure of 29 stores had been announced, reflecting the near-complete trade-out of stock at these locations and the absence of offers from interested parties. The Group will vacate these premises following closure and all associated employees will be made redundant.

*Operational properties*

In addition to the retail stores, the Group operated a head office from London Road, Liverpool, and two distribution centres also based in Liverpool.

The head office was included in the sale to LHR and the Group has now vacated the distribution centres.

*Other property assets*

Other property interests comprise a long leasehold for a small car park located close to the Liverpool head office and a freehold vacant annex attached to the Bradford property. These sites are being marketed for sale by our agents, with the Bradford property due to be offered for sale at auction in October 2011.

*Cash in hand/transit*

At the date of our appointment we estimate approximately £6.0m of cash in hand or in transit, summarised as follows

Retentions held by MSPs and cash collection agents currently total £1.0m and we are currently in discussion with these parties to seek the release of these amounts, albeit we anticipate that a proportion will be retained against chargebacks (customer refunds) and other costs likely to be incurred by the service providers.

*Debtors and prepayments collections*

TJH's debtor ledgers indicate that at the date of appointment there was a total of £1.1m owed to the company

*Debit supplier balances*

We understand that a significant proportion of this balance (£0.9m) is attributable to debit balances on TJH's purchase ledger, relating to faulty goods claims, shortfalls in goods supplied and other supplier disputes. Whilst we continue to engage with the relevant suppliers to recover these monies where possible, there is a risk that a significant proportion of these balances will be unrealisable.

*Voucher and other debtors*

The remainder of the debtor balances comprise third party vouchers which require redemption (c. £0.1m) and other debtors (c. £19,000). However, the majority of these debts are not yet due for payment. Realisations to date total £3,300 and we continue to actively pursue the collection of the remainder of these amounts.

*Prepayments*

TJH's records indicate that at the date of appointment there were prepaid balances of £6.0m on the company's balance sheet. However, we understand that the majority of these balances relate to rent and rates liabilities which had not been settled at the date of appointment following the freezing of bank accounts, and so are not recoverable.

To date we have received c. £0.2m in respect of refunds on business rates relating to 21 sites. We continue to pursue business rates prepayments and any appropriate rating appeals.

#### ***Customer orders***

At the date of our appointment, company records indicated that a small number of internet and other customers had paid for goods which had not yet been delivered. We have sought to secure the release of these goods where they were held by third party carriers. The Joint Administrators were also able to release customer orders for collection subject to the goods being fully paid for, a valid receipt being held by the customer and confirmation that the goods in question had been set aside in store specifically for the customer's collection. Regrettably TJH has been unable to fulfil any outstanding customer orders which had not been dispatched from the Group's distribution centre at the date of appointment. Customers who fall within this category will be non-preferential creditors in the TJH Administration.

Customers with outstanding orders identified by company records or those that have contacted the Joint Administrators directly since appointment have been advised in writing of the position relating to their goods

#### ***Stock and Retention of Title***

At the date of appointment, TJH had stock of £38.4m at net book value.

To date we have received ROT claims from 212 suppliers claiming title in goods supplied to TJH. The total value of these claims is estimated at £15.9m and we continue to investigate these claims in conjunction with our legal advisors

#### ***Intellectual property assets***

Since our appointment, discussions have been held with a number of interested parties in respect of TJH's intellectual property assets

The business name and intellectual property of TJH were sold to LHR within the 8 August 2011 transaction.

#### ***Fixtures and fittings***

Fixtures and fittings relate to store and distribution centre racking, IT equipment, office furniture, materials handling equipment and various other items of plant

Given the age of store fittings, costs of dismantling and removal, and low realisable values in the second hand market we do not envisage material realisations from fixtures and fittings

#### ***Employees***

At the date of appointment, 3,497 employees were employed by TJH. This is made up as follows:

Following our appointment, measures were taken to reduce the overhead cost base of the business which has to date included the redundancy, for economic and organisational

reasons, of 85 employees at the head office and 117 redundancies at the distribution centres.

All 3,235 store employees were initially retained to allow trading to continue. Salary payments for those employees have been made as usual, with the gross July payroll totalling c. £2.2m. Outstanding pre appointment overtime payments have also been paid to all staff employed at the date of appointment as part of the July payroll.

As outlined earlier in this report, 442 store employees (included in the 3,235 total store employees) were transferred to LHR on 8 August 2011, with an additional 134 store employees transferring under the terms of the sale of the two additional stores completed on 10 August 2011.

As a result of the 30 store closures announced as at 10 August 2011, the redundancy of 1,270 employees is expected for economic and organisational reasons.

#### **Administrators' receipts and payments**

A summary of the Administrators' receipts and payments for the period from 30 June 2011 to 22 July 2011 is attached at Appendix D.

#### **Initial meeting of creditors**

The Joint Administrators are of the opinion that the Companies have insufficient property to enable a distribution to be made to non-preferential creditors other than by virtue of the Prescribed Part and consequently, in accordance with the provisions of paragraph 52(1) of Schedule B1 to the Act, they do not intend to call an initial creditors' meeting for any of the Companies.

The Joint Administrators will be obliged to call an initial meeting of creditors of an individual company if it is requested by creditors whose debts amount to at least 10% of the total debts of that company. The request must be made within 8 business days of the date on which these proposals are issued (or such longer period as the Court may allow) and must be in the prescribed form. The creditor summoning the meeting must lodge with the Joint Administrators a deposit as security for the expenses of summoning and holding the meeting. Further information is provided in the covering letter accompanying these proposals.

#### **Future conduct of the Administrations**

The Joint Administrators will continue to deal with the Administrations in line with the stated objectives. Further tasks will include, but are not limited to:

- ▶ Realisation of stock through continued trading of the business, including finalising and settling all trading liabilities;
- ▶ Continuing the current sale of business strategy to realise value for stores in the Group's leasehold portfolio,
- ▶ Dealing with the wider property portfolio including lease assignments, if a purchaser is found, and landlord surrenders,
- ▶ Dealing with all ROT claims in respect of goods supplied to the Group,
- ▶ Realisation of all other assets where possible,
- ▶ Completion of statutory requirements of the Administrations, including reporting to creditors,
- ▶ Preparing corporation tax returns and VAT returns,

- ▶ Dealing with employee redundancies, preferential claims, and any other employee related matters,
- ▶ Repayment of debts due to the secured lenders of the Group; and
- ▶ Matters relating to the Prescribed Part.

#### **The end of the Administrations**

It is proposed that the end of the Administrations will either be through a creditors' voluntary liquidation or dissolution. Further details are provided below

#### ***Creditors' Voluntary Liquidation (CVL)***

It is proposed that, at the end of the Administrations, if any of the Companies have any property which might permit a distribution to its creditors (including in respect of the Prescribed Part), it will move straight into CVL upon the filing with the Registrar of Companies of a notice pursuant to paragraph 83 of Schedule B1 to the Act. It is proposed that the Liquidators be Thomas Andrew Jack and Simon Allport of Ernst & Young LLP and that any act required or authorised under any enactment to be done by the Liquidators may be done by either or both of them. In accordance with paragraph 83(7) of Schedule B1 to the Act and Rule 2.117A(2)(b) of the Rules, creditors may nominate a different person as the proposed Liquidator provided that the nomination is made after the receipt of these proposals and before the proposals are approved. It should be noted in this regard that a person must be authorised to act as an insolvency practitioner in order to be appointed as Liquidator.

#### ***Dissolution***

It is proposed that if at the end of the Administrations the company concerned has no property which might permit a distribution to its creditors, the Administrators will send notice to that effect to the Registrar of Companies. On registration of the notice, the Joint Administrators' appointments will come to an end. In accordance with the provisions of paragraph 84(6) of Schedule B1 to the Act, the company will be deemed to be dissolved three months after the registration of this notice

### 3. Statement of Affairs

The Director has submitted Statements of Affairs for the Companies as at 30 June 2011. Summaries are attached at Appendix B. We would comment that a number of the asset values have yet to be determined and may be lower than indicated. Similarly, a number of creditor claims have yet to be quantified and may be higher than indicated. Additionally, the values are shown before applicable costs of realisation.

We note that the Director was in office for only a short time prior to the appointment of Administrators so had only limited knowledge of the Group's affairs.

We include below a summary of our comments on the Director's Statements of Affairs:

#### Group

- ▶ The debts due to the secured lenders (which the Director estimates total £23.8m) have not been apportioned between each of the four companies in the Group and have been applied in full against the fixed charge assets expected to be realised by each of the Companies. However, there are Group-wide cross guarantees in favour of the secured lenders and the debts due to the secured lenders outweigh the estimated fixed and floating charge realisations, and therefore it is estimated that the only funds available for non-preferential creditors will be by virtue of the Prescribed Part in TJH, and
- ▶ The Statements of Affairs do not include liabilities in respect of loans advanced by PPM Capital to the Group at the time of the management buy-out in November 2003. The books and records of the Companies state that, at the date of Administration, the remaining unsecured balances in respect of the loans (which also include accrued loan interest and dividends payable) total £8.7m

#### TJH

- ▶ The Director has not forecast any realisations from leasehold property interests in TJH. Since the submission of the Statement of Affairs, actual realisations from leasehold property interests have totalled c. £1.0m since our appointment;
- ▶ The Director has also included in the Statement of Affairs an estimate for contingent claims in respect of landlords (based upon annual rent, service charges and insurance over the remaining term of the Companies' property leases). These amounts serve as an estimate only and will be dependent upon the final outcome of property disposals within the retail store portfolio and future actions by landlords to mitigate any potential claims,
- ▶ The stock balance is shown net of claims (if any) for ROT from suppliers (estimated by the Director at £7.5m). Following the decision to continue to trade, the bulk of the stock will be sold in the normal course of business. It is anticipated that trading will generate a surplus, the quantum of which remains unknown, and is subject to ROT, utilities, salaries and all trading liabilities which will need to be finalised, together with any relevant taxation,
- ▶ Individual trade creditor balances are shown gross of estimated ROT claims, and therefore the actual value of individual trade creditor claims may reduce as valid ROT claims are settled;
- ▶ Final realisations from cash at the date of appointment are subject to potential chargeback claims from MSPs in relation to customers that have not received goods ordered prior to our appointment via the internet or from stores. Retentions held by

MSPs in this regard currently total c. £1.0m although negotiations are ongoing to finalise this liability and seek to release any surplus monies; and

- The corporation tax debtor is reported at book value (estimated by the Director) at £3.6m. Since our appointment, we have assessed the validity of this debtor in light of information that has been provided to us from TJH's previous tax advisors. Based on the information received, we estimate the realisable value in respect of this debtor is likely to be nil.

We provide below, for information, an indication of the current position with regard to creditors' claims. The figures have been compiled by Group management and have not been subject to independent review or statutory audit.

#### **Secured creditors**

At the date of our appointment, the Companies operated a stock facility with Burdale, drawn to c. £7.3m. In addition, Burdale provided a seasonal loan facility to the Companies, drawn to £5.7m, before interest and charges. At the date of appointment, Endless LLP had a £10.2m loan, ranking behind the indebtedness due to Burdale. On 6 July 2011, Endless LLP assigned its rights and security in this indebtedness to GA Europe 300 Limited.

Since our appointment, Burdale has advised us of post appointment fees and charges totalling c. £0.6m, comprising £0.4m outstanding arrangement fees from the March 2011 refinance and £0.2m subsequent termination charges and other fees. Accordingly, the total amount owing to secured creditors as at 30 June 2011 is estimated to be c. £23.8m (before the application of any relevant charges or fees relating to Endless LLP's secured lending).

We estimate that Burdale, the first ranking secured creditor, will be repaid in full. However, at this time we estimate that the second ranking secured creditor will not be repaid in full.

#### **Preferential creditors**

The Joint Administrators currently estimate preferential creditor claims of c. £0.7m, in respect of claims for employees' salaries, holiday pay and pension contributions. As the sole employer in the Group, these will attributable to TJH.

The Joint Administrators believe, based on current estimates of realisations in the Administrations, that TJH preferential creditors will be repaid in full.

To date £3k has been paid in respect of these claims and the Joint Administrators anticipate that all preferential claims will be paid in full as soon as they are agreed. The value of potential preferential claims has been mitigated through the sale of a number of stores to LHR.

#### **Non-preferential creditors**

Non-preferential creditor claims continue to be submitted. The Director's Statements of Affairs estimates that total non-preferential claims for the Companies will be in the region of £409m. This includes the Director's estimate of the full value of outstanding liabilities over the remaining period of the Group's leasehold agreements. Final claims in the Administration may be higher due to contingent claims and other non-preferential creditor amounts not included in the Statements of Affairs, but also could reduce as landlords mitigate losses through reletting of premises or where leases can be assigned or surrendered.

At this time we estimate there will not be sufficient funds to enable any distribution to non-preferential creditors other than in respect of the Prescribed Part.

## 4. Prescribed Part

The Prescribed Part is a proportion of floating charge assets set aside for non-preferential creditors pursuant to section 176A of the Act. The Prescribed Part applies to floating charges created on or after 15 September 2003.

### TJH

At this time the outcome of the Administration remains uncertain and therefore we are unable to accurately estimate the value of TJH's net property. However, to the best of our knowledge and belief we estimate the value of net property to be approximately £10m and we estimate that the value of the Prescribed Part to be set aside in TJH will be the maximum £600,000, before the costs of dealing with the Prescribed Part.

### Holdings

The value of the Prescribed Part in Holdings is estimated to be £nil.

### Investments

The value of the Prescribed Part in Investments is estimated to be £nil

### Properties

The value of the Prescribed Part in Properties is estimated to be £nil.

## 5. Administrators' remuneration and disbursements and payments to other professionals

### Remuneration

The statutory provisions relating to remuneration are set out in Rule 2.106 of the Rules. Further information is given in the Association of Business Recovery Professionals' publication 'A Creditors' Guide to Administrators' Fees', a copy of which may be accessed from the web site of the Insolvency Practitioners Association at <http://www.insolvency-practitioners.org.uk> (follow 'Regulation and Guidance' then 'Creditors' Guides to Fees'), or is available in hard copy upon written request to the Joint Administrators.

In the event that creditors' meetings are not requisitioned and Creditors' Committees are not formed in each or any of the companies, the Joint Administrators will seek to have their remuneration fixed by the secured and preferential creditors in accordance with Rule 2.106(5A) of the Rules. The Joint Administrators will ask for their remuneration to be fixed on the basis of time properly given by them and their staff in dealing with matters arising in the Administrations.

Attached at Appendix C is a detailed analysis of time spent and charge out rates, for each grade of staff for the various areas of work carried out to 5 August 2011, as required by the Association of Business Recovery Professionals' Statement of Insolvency Practice No. 9. At this date our total time costs amount to £1,444,506 across the Group

Aspects of the TJH Administration where significant time costs have been incurred include:

- ▶ Visiting the 56 trading premises located around the UK upon appointment and taking control of company assets (564.7 hours),
- ▶ Continued trading within Administration (1,421.2 hours); and
- ▶ Dealing with the large number of ROT claims that have been submitted (862.0 hours).

Other matters include sale of business and properties, employee matters and dealing with creditor enquiries and claims

### Disbursements

Appendix C also includes a statement of the Joint Administrators' policy for charging disbursements. In the event that creditors' meetings are not requisitioned and Creditors' Committees are not formed, the Joint Administrators will seek the approval of the secured and preferential creditors to charge Category 2 disbursements

## 6. Pre-Administration costs

The Administrators also seek approval for payment of unpaid pre-Administration time costs totalling £55,035 plus VAT, and pre-Administration expenses totalling £292 plus VAT in respect of TJH. The payment of unpaid pre-Administration costs as an expense of the Administration is subject to approval under Rule 2.67A, and not part of the proposals subject to approval under paragraph 53. This means that they must be approved separately from the proposals

A breakdown of the total pre-Administration time costs and expenses incurred is attached at Appendix E. No amounts were paid pre-Administration.

- The work undertaken by Ernst & Young LLP pre-Administration was undertaken to ensure the impact of alternative insolvency options was properly considered and therefore maximise the benefit of an insolvency to the Group's creditors, consistent with the purposes and objectives of the Administrations. This work may be summarised as follows:
  - ▶ Liaison with Group management and analysis regarding the potential impact of and outcome from a potential insolvency;
  - ▶ Liaison with Group management and analysis regarding enabling TJH to continue to trade in Administration; and
  - ▶ Planning for the Administration, in order to maximise the returns to creditors.

In the event that a creditors' meeting is not requisitioned and a Creditors' Committee is not formed in respect of any of the Companies, the Joint Administrators will seek to have the unpaid pre-Administration costs approved by the secured and preferential creditors to be paid as an expense of the Administrations

### **Administrators' charging policy for disbursements**
