**1 Statutory information**

C4 Fire Protection Limited is a private company, limited by shares, registered in England and Wales, registration number 04990532. The registered office is 24 Cherry Blossom Way, Sparkford, Yeovil, Somerset, BA22 7FW.

**2 Director's advances, credit and guarantees**

The director owed the company £13,981 at the year end. This amount was subject to interest at the beneficial loan official rate and has been repaid to the company after the year end.

**3 Average number of employees**

During the year the average number of employees was 1 (2020: 1).

For the year ending 31 December 2021 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
