#### 2. INTRODUCTION

2.1 The company's affairs are now fully wound up and the Liquidator is in a position where he is able to issue his final account.

- 2.2 Attached at Appendix 1 is the Liquidator's final Receipts and Payments Account, which also shows figures for the period from 5 July 2019 to 29 August 2019 and a comparison to the Statement of Affairs values. This also details the remuneration and expenses drawn during the Liquidation, further details of which are provided below.
- 2.3 This report contains a description of the things done by the office-holder in the period from 5 July 2019 to 29 August 2019 and should be read in conjunction with the Liquidator's previous annual progress reports.

3.1 There have been no realisations in the period and none were expected. The Liquidator has been concluding his administration of this liquidation.

**Unrealised Assets** 

3.2 There are no assets which remain to be realised.

#### 4. OUTCOME FOR CREDITORS

Secured Creditors

4.1 There are no secured creditors in this matter.

Preferential Creditors

- 4.2 The director's Statement of Affairs ("S of A") detailed that there were preferential creditors of £3,600 in respect of arrears of wages and holiday pay.
- 4.3 There is no prospect of a distribution to preferential creditors as the funds realised have already been used for defraying the expenses of the liquidation.

Prescribed Part pursuant to Section 176A of the Insolvency Act 1986

- 4.4 Under Section 176A of the Act a Liquidator is required to set aside a proportion of the realisations for unsecured creditors where there is a secured creditor who holds a qualifying floating charge created on or after 15 September 2003. This is known as the Prescribed Part.
- 4.5 As there are no qualifying floating charges registered at Companies House, the Prescribed Part does not apply in this matter.

**Unsecured Creditors** 

- 4.6 The S of A detailed unsecured creditors of £59,162. As at the date of this report, claims totalling £17,261 have been received from unsecured creditors.
- 4.7 In accordance with Rule 14.36 of the Insolvency (England & Wales) Rules 2016 the Liquidator confirms that that no dividend will be declared as the funds realised have already been used for paying the expenses of the Liquidation.

Remuneration

- 5.1 No steps have been taken to fix the basis of the Liquidator's remuneration and therefore no remuneration has been drawn in this matter.
