

1 Introduction

- I, Mike Rollings of Rollings Butt LLP, 6 Snow Hill, London, EC1A 2AY, was appointed as Joint Liquidator of Cogenco Services Limited ("the Company") on 19 January 2017. On the same day, I was appointed Liquidator of ten other group companies ("the Companies"); all of which are shown at Appendix D. The affairs of the Company are now fully wound-up and this is my final account of the liquidation, which covers the period since my appointment to 3 July 2017 ("the Period").
- 1.2 The trading address of the Company was 210 Pentonville Road, London, N1 9JY. The business traded under the name Cogenco Services Limited.
- 1.3 The registered office of the Company was changed to 6 Snow Hill, London, EC1A 2AY and its registered number is 05017647.

2 Receipts and Payments

2.1 At Appendix A, I have provided an account of my Receipts and Payments for the Period with a comparison to the directors' Declaration of Solvency, which provides details of the remuneration charged and expenses incurred and paid by the Joint Liquidators.

3 Work undertaken by the Liquidator

- 3.1 This section of the report provides creditors with an overview of the work undertaken in the liquidation since the date of my appointment.
- 3.2 On appointment as Liquidators, the statutory compliance matters required on appointment as Liquidators were undertaken. Notice of our appointment as Liquidators was published in the London Gazette, along with a notice that creditors who were required, on our before 27 February 2017 to prove their claim.
- 3.3 The Company had no assets or liabilities, and I can confirm that as a result of inviting any creditors to submit a claim, no such claims were received.
- The main issue to be clarified to enable the liquidation to be concluded was confirmation from HM Revenue & Customs (HMR&C) that there were no outstanding matters in respect of the Company's tax affairs and no objection to conclusion of the liquidation. This confirmation was duly received from both the HMR&C office who deal with Members' Voluntary Liquidations, and the national HMR&C office.

4 Distributions to Members

4.1 The Company had no assets and therefore there were no distributions made to members.

5 Liquidator's Remuneration

- 5.1 The members approved that the basis of the Liquidator's remuneration be fixed by reference to the time properly spent by him and his staff in managing the Liquidation.
- My time costs for the period from the date of appointment are £1,393.02. This represents 6.15 hours at an average rate of £226.51 per hour. Attached as Appendix C is a Time Analysis which provides details of the activity costs incurred by staff grade during this period in respect of the costs fixed by reference to time properly spent by me in managing the Liquidation. I would confirm that to date no fees have been billed, however disbursements relating to statutory advertising and the Joint Liquidators' statutory bond have been billed

- 5.3 Attached as Appendix C is additional information in relation to this firm's policy on staffing, the use of subcontractors, disbursements and details of our current charge-out rates by staff grade.

Staff allocation and the use of subcontractors
