Figure 1. The schematic diagram of the proposed system. The system is composed of a host computer and a mobile robot. The host computer is connected to the mobile robot via a serial cable. The mobile robot is equipped with a camera and a laser range finder. The host computer sends commands to the mobile robot and receives data from the mobile robot. The mobile robot moves in the environment and collects data. The host computer processes the data and generates a map of the environment. The mobile robot uses the map to navigate and avoid obstacles.
