The Chairman confirmed that at the last meeting his proposals had been accepted but the meeting had been adjourned for him to consider the proposed appointment of Andrew Phillip Wood as a third Administrator and to receive Mr Wood's consent to act or alternatively the appointment of a creditors committee failing that
