- (1) THAT in substitution for any existing and unexercised authority, the directors be generally and unconditionally authorised to exercise all the powers of the Company to allot relevant securities (within the meaning of section 80(2) of the Companies Act 1985) (the "Act") up to an aggregate nominal value of £681,552 such authority to expire on the earlier of the conclusion of the Annual General Meeting of the Company next following the passing of this resolution or fifteen months after the date of this resolution, save that the directors may before such expiry make an offer or agreement which would or might require relevant securities to be allotted after such expiry and may allot relevant securities pursuant to such an offer or agreement as if the authority conferred hereby had not expired; and
- THAT, in substitution for any existing and unexercised powers, the directors be and are hereby empowered pursuant to section 95 of the Act to allot equity securities (as defined in section 94 of the Act) for cash pursuant to the authority given in the previous resolution as if section 89(1) of the Act did not apply to such allotment, provided that such power be limited to:
 - the allotment of equity securities which are offered to all the holders of equity securities of the Company (at a date specified by the directors) where the equity securities respectively attributable to the interests of such holders are as nearly as practicable in proportion to the respective number of equity securities held by them, but subject to such exclusions and other arrangements in relation to fractional entitlements and any legal or practical problems under any laws, or requirements of any regulatory body or stock exchange in any territory or otherwise;
 - (ii) the allotment (otherwise than pursuant to sub-paragraph (2) (i) of equity securities up to an aggregate nominal amount of £265,542.325; and

(iii) In addition to the power pursuant to sub-paragraph (2) (ii) (otherwise than pursuant to sub-paragraph (2) (i)) of equity securities up to an aggregate nominal value of £ 62,401,

and this power shall expire on the earlier of the conclusion of the Company's next Annual General Meeting and fifteen months from the date of the passing of this resolution save that the Company may make an offer or enter into an agreement before the expiry of that date which would or might require equity securities to be allotted after that date and the directors may allot equity securities in pursuance of such an offer as if the power conferred hereby had not expired.

- 7.2 the allotment (otherwise than pursuant to sub-paragraph (10.1)) of equity securities up to an aggregate nominal amount of £500,000;

and this power shall expire on the earlier of the conclusion of the Company's next Annual General Meeting and fifteen months from the date of the passing of this resolution save that the Company may make an offer or enter into an agreement before the expiry of that date which would or might require equity securities to be allotted after that date and the directors may allot equity securities in pursuance of such an offer as if the power conferred hereby had not expired.
