The Company was placed into members' voluntary liquidation on 9 November 2018 when Laura Waters and Robert Lewis were appointed Joint Liquidators (the Liquidators).

We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 9 November 2018 to 12 August 2019 and also serves as a progress report from 9 November 2018 to 12 August 2019.

We are also required to give you certain information about the Company and the Liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

#### REPORT ON THE LIQUIDATION

#### Realisation of assets:

The directors' Declaration of Solvency showed that the Company's assets were:

Realisations from the Company's assets are as detailed in the above summary and totalled £5,028.03.

No additional assets have been identified. There are no assets still to be realised.

#### Settlement of liabilities:

The directors' Declaration of Solvency and the Company's records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No such claims were received.

#### **HMRC:**

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities and they have no objections to the closure of the liquidation.

#### Distributions to shareholders:

At the time of our appointment, the issued share capital of the Company consisted of 111 Ordinary £1 shares.

During the liquidation, we made a final distribution in specie of £5,028.03 (representing £45.30 per share) to the Ordinary shareholders.

The distribution in specie consisted of the inter group debtor held along with any other assets of the Company.

Our time costs incurred to 24 May 2019 during the liquidation in relation to the Company and 14 connected UK liquidations totalled £[45,000], of this time, £2,200 has been raised and settled in respect of the liquidation costs for the Company.

#### Liquidators' expenses:

During the liquidation we have incurred category 1 disbursements of £459 plus VAT relating to the Company and 14 connected UK liquidations.
