3. Resolutions

 - (a) following shareholder approval, to approve the new articles of association in the form attached to this resolution and with effect from the date of such shareholder approval to adopt the new articles of association as the articles of association of the Company in substitution for and to the exclusion of the existing articles of association;
 - (b) that following shareholder approval, any director be authorised to take such actions and do anything as may be required (including execution of any documentation) to approve the new articles of association and adopt the new articles of association as the articles of association of the Company;
 - (c) to approve, having consented to act, each of Ben Loper, Derek De Salvia, Kevin Speidel and Neil Hutchinson as directors of the Company;
 - (d) to approve each of the Documents, subject to such amendments as any director may consider necessary or desirable;
 - (e) that any director is authorised to sign on behalf of the Company and to approve, execute, deliver, complete and/or perform, and to procure to be executed, delivered, completed and/or performed, on behalf of the Company, all such other documents as may be necessary or desirable in connection with the appointments detailed above;
 - (f) that any director in the presence of a witness, is authorised on behalf of the Company to execute and deliver the Deed of Indemnity, and any other deed, instrument, certificate or document, required to be executed as a deed by the Company in connection with the resignation and appointments detailed above; and
 - (g) that following the passing of these written resolutions, the company secretary be instructed to:
 - (i) circulate the proposed shareholder written resolution authorising the adoption of the new articles of association to the sole shareholder of the Company;
 - (ii) update the Company's register of directors to reflect the resignation and appointments; and
 - (iii) to arrange for the necessary forms and documents to be filed at Companies House within the prescribed time limits.
