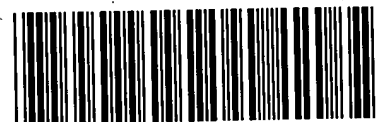

The directors present their report and the financial statements for the year ended 31 March 2015.

Directors' Responsibilities

The directors do not recommend the payment of a dividend.

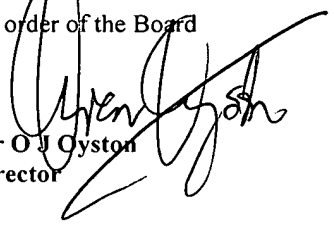

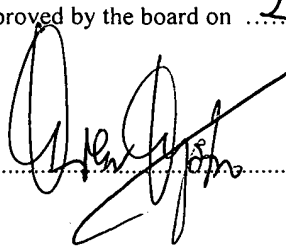
For the year ended 31st March 2015 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.
