- The £100,000 Debenture is deemed to be valid by the court and the security was submitted 1/ to Companies House in good time and prior to the administrator being appointed, and the detail of the security should be no more onerous or detailed that the minutes of the board meeting of 12th March stated, as otherwise the board should have been given the opportunity to approve a more detailed or onerous debenture.
