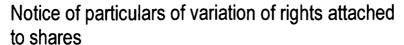

the holders of Ordinary B Shares voting on any resolution shall between them be entitled to cast and shall be deemed to have cast such number of votes as represents 5% of all votes cast by all shareholders voting on that resolution.

Dividends: any dividends or distributions shall be paid to the holders of the Ordinary A Shares and the Ordinary B Shares as if such shares constituted one class of share.

Return of Capital: on a return of capital, on liquidation or otherwise the surplus assets of the Company remaining after payment of its liabilities shall be applied as follows: (1) first, in payment of any dividends declared before the winding-up but unpaid, and (2) secondly, the balance (if any) of such surplus assets shall belong to and be distributed to the Shareholders between them pro rata to their respective holdings of Shares.

Redemption: there shall be no rights of redemption in respect of the Ordinary A Shares or Ordinary B Shares.
