

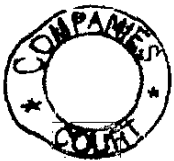

CONSENT ORDER

UPON THE APPLICATION of Timothy Bramston of Griffins, of Tavistock House South, Tavistock Square, London, WC1H 9LG (the "Applicant")

AND UPON READING the Witness Statement of Timothy Bramston dated 22 September 2016 and Exhibit TB1 thereto

AND UPON READING the Witness Statement of Louise Bell dated 31 October 2016

AND UPON the Secretary of State confirming that he consents to the Court making such order as it sees fit so long as no order for costs is made against either the Secretary of State or the Official Receiver

IT IS ORDERED BY CONSENT THAT:

1. The cases listed in Schedules A to C attached to this Order, in so far as there are currently proceedings in the County Court or in a District Registry be transferred to the High Court in London for the purpose of making the Orders listed below.
2. Pursuant to Section 171(2) of the Insolvency Act 1986, the Applicant be removed from the office of liquidator of the companies listed at rows 1 to 16 of Schedule A to this Order. The First Respondent shall remain in office as liquidator.

3. The Applicant be removed from office as Liquidator with immediate effect pursuant to Section 171(2) of the Insolvency Act 1986 of each of the Companies listed:
  - 3.1 in rows 17 to 19 of Schedule A to this Order and Kevin Goldfarb be appointed as Liquidator in place of the Applicant such appointment to take effect from the date of this Order; and
  - 3.2 in rows 20 to 33 of Schedule A to this Order and the First Respondent be appointed as Liquidator in place of the Applicant such appointment to take effect from the date of this Order.
4. The Applicant be removed from office as Liquidator with immediate effect pursuant to Section 171(2) of the Insolvency Act 1986 of the company listed at row 34 of Schedule A to this Order and the First Respondent be appointed as Liquidator in place of the Applicant such appointment to (i) be held jointly and severally with the Third Respondent who remains in office and (ii) take effect from the date of this Order.
5. The Applicant be removed from office as Liquidator with immediate effect pursuant to Section 171(2) of the Insolvency Act 1986 of company listed at row 35 of Schedule A to this Order and Kevin Goldfarb and Adam Harris be appointed as Joint Liquidators in place of the Applicant such appointment to be joint and several and to take effect from the date of this Order.
6. Pursuant to Section 172(2) of the Insolvency Act 1986, the Applicant be removed from the office of liquidator of the companies listed at rows 1 to 7 of Schedule B to this Order. The First Respondent shall remain in office as liquidator.
7. Pursuant to Section 172(2) of the Insolvency Act 1986, the Applicant be removed from the office of liquidator of the company listed at row 8 of Schedule B to this Order. The Second Respondent shall remain in office as liquidator.
8. The Applicant be removed from office as Liquidator with immediate effect pursuant to Section 172(2) of the Insolvency Act 1986 of each of the Companies listed in:
  - 8.1 rows 9 to 23 of Schedule B to this Order and Kevin Goldfarb be appointed as Liquidator in place of the Applicant such appointment to take effect from the date of this Order; and
  - 8.2 rows 24 to 39 of Schedule B to this Order and the First Respondent be appointed as Liquidator in place of the Applicant such appointment to take effect from the date of this Order.
9. The Applicant be removed from office as Liquidator with immediate effect pursuant to Section 172(2) of the Insolvency Act 1986 of the company listed at row 40 of Schedule B to this Order and Kevin Goldfarb and Adam Harris be appointed as Joint Liquidators in place of the Applicant such appointments to (i) be held jointly and severally; and (ii) take effect from the date of this Order.

10. Pursuant to Section 298(1) of the Insolvency Act 1986, the Applicant be removed from the office of Trustee in Bankruptcy of the individuals listed at rows 1 and 2 of Schedule C to this Order. The First Respondent shall remain in office as Trustee in Bankruptcy.
11. The Applicant be removed from office as Trustee in Bankruptcy with immediate effect pursuant to Section 298(1) of the Insolvency Act 1986 of the individual listed at row 3 and 4 of Schedule C to this Order and the First Respondent be appointed as the Trustee in Bankruptcy in place of the Applicant such appointment to take effect from the date of this Order.
12. The Applicant be removed from office as Trustee in Bankruptcy with immediate effect pursuant to Section 298(1) of the Insolvency Act 1986 of the individual listed at row 5 to Schedule C to this Order and Kevin Goldfarb be appointed as the Trustee in Bankruptcy in place of the Applicant such appointment to take effect from the date of this Order.
13. The Applicant be removed from office as Trustee in Bankruptcy with immediate effect pursuant to Section 298(1) of the Insolvency Act 1986 of each of the individuals listed:
  - 13.1 In rows 6 to 7 of Schedule C to this Order and the First Respondent and Adam Harris be appointed as Joint Trustees in Bankruptcy in place of the Applicant such appointments to (i) be held jointly and severally; and (ii) take effect from the date of this Order; and
  - 13.2 In rows 8 to 14 of Schedule C to this Order and Kevin Goldfarb and Adam Harris be appointed as Joint Trustees in Bankruptcy in place of the Applicant such appointments to (i) be held jointly and severally; and (ii) take effect from the date of this Order.
14. The First Respondent, Adam Harris and Kevin Goldfarb (together the "**Successor Practitioners**") shall give notice of their appointments, as applicable, to all creditors of the estates listed at rows 17 to 35 of Schedule A, rows 9 to 40 of Schedule B and rows 3 to 14 of Schedule C to this Order within 28 days of the date of this Order by way of advertisement in the London Gazette.
15. All creditors to the estates listed in rows 17 to 35 of Schedule A, rows 9 to 40 of Schedule B and rows 3 to 14 of Schedule C of this Order do have permission to apply to the Court, on Notice to the Applicants and the Successor Practitioners within 56 days of the advertisement referred to in paragraph 15 above for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor.
16. Nothing in this Order requires the time for production of any progress report in respect of the estates listed in Schedules A to C of this Order to be varied.
17. The time for service of the Application Notice upon the Respondents be abridged.

18. There be no Order as to costs.

19. The Applicant has permission to apply.
