The holder of an ordinary share has the right to receive notice of and participate in general meetings in person, by proxy or (if a corporation) by representative, and has one vote per share

Dividend rights

Unless the members' resolution to declare, or directors' decision to pay, a dividend specifies otherwise, each holder of an ordinary share is entitled to receive such proportion of any profits that are not required to pay a preferential dividend and that the Company distributes as is equal to the proportion that his holding represents of the total number of ordinary shares in issue on the date of the resolution or decision to declare or pay it.
