Prescribed particulars	<p data-bbox="359 477 507 504">Voting rights</p> <p data-bbox="359 539 1134 633">The holder of an ordinary share has the right to receive notice of and participate in general meetings in person, by proxy or (if a corporation) by representative, and has one vote per share</p> <p data-bbox="359 669 536 696">Dividend rights</p> <p data-bbox="359 701 1134 1149">Unless the members' resolution to declare, or directors' decision to pay, a dividend specifies otherwise, each holder of an ordinary share is entitled to receive such proportion of any profits that are not required to pay a preferential dividend and that the Company distributes as is equal to the proportion that his holding represents of the total number of ordinary shares in issue on the date of the resolution or decision to declare or pay it. The Company may, by ordinary resolution on the recommendation of the directors, decide to pay all or part of a dividend or other distribution payable in respect of an ordinary share by transferring non-cash assets of equivalent value (including, without limitation, shares or other securities in any company). Holders may waive their entitlement to a dividend or other distribution payable in respect of an ordinary share by giving the Company notice in writing to that effect.</p> <p data-bbox="359 1184 587 1211">Capital distributions</p> <p data-bbox="359 1216 1134 1697">The directors may, if they are so authorised by an ordinary resolution, capitalise any profits of the Company (whether or not they are available for distribution) which are not required for paying a preferential dividend, or any sum standing to the credit of the Company's share premium account or capital redemption reserve and appropriate such sum to the holders of ordinary shares as if it were distributed by way of dividend and in the same proportions. Any capitalised sum may be applied in paying up new shares of a nominal amount equal to the capitalised sum which are then allotted credited as fully paid to the persons entitled or as they may direct, and/or (if appropriated from profits available for distribution) it may be applied in or towards paying up any amounts unpaid on existing shares held by the persons entitled or in paying up new debentures of the Company which are then allotted credited as fully paid to the persons entitled or as they may direct.</p> <p data-bbox="359 1702 1134 1825">On a return of assets on liquidation, any surplus assets of the Company remaining after payment of its liabilities shall be distributed amongst the holders of the ordinary shares in proportion to their respective holdings.</p> <p data-bbox="359 1861 501 1888">Redemption</p> <p data-bbox="359 1892 767 1919">Ordinary shares are not redeemable</p>
