ANY CAPITALISED SUM MAY BE APPLIED IN PAYING UP NEW SHARES OF A NOMINAL AMOUNT EQUAL TO THE CAPITALISED SUM WHICH ARE THEN ALLOTTED CREDITED AS FULLY PAID TO THE PERSONS ENTITLED OR AS THEY MAY DIRECT; AND/OR (IF APPROPRIATED FROM PROFITS AVAILABLE FOR DISTRIBUTION) IT MAY BE APPLIED IN OR TOWARDS PAYING UP ANY AMOUNTS UNPAID ON EXISTING SHARES HELD BY THE PERSONS ENTITLED OR IN PAYING UP NEW DEBENTURES OF THE COMPANY WHICH ARE THEN ALLOTTED CREDITED AS FULLY PAID TO THE PERSONS ENTITLED
